IN THE UNITED STATES PATENT AND TRADEMARK OFFICE

ASSIGNMENT

WHEREAS, Colony Resorts LVH Acquisitions, LLC, a Nevada limited liability company (“ASSIGNOR”), prior to the termination of its business operations, owned certain trademarks and/or service marks, and applications and/or registrations for such marks, as listed in Exhibit A attached hereto and incorporated herein by this reference (“MARKS”); and

WHEREAS, 3000 Paradise Road, L.L.C., a Delaware limited liability company (“ASSIGNEE”), has acquired all of the right, title and interest of ASSIGNOR in, to and under the MARKS, together with the goodwill of the business symbolized by the MARKS, as discussed below;

WHEREAS, ASSIGNOR executed certain promissory notes in favor of Goldman Sachs Mortgage Company, a New York limited partnership (“GSMC”), each dated as of July 30, 2010 (the “NOTES”), which obligations are secured by that certain Deed of Trust, Security Agreement, Assignment of Leases, Rents and Revenues and Fixture Filing, dated as of May 11, 2006 (the “DEED OF TRUST”);

WHEREAS, GSMC assigned all of its right, title, interest, claim or demand arising under the NOTES and the DEED OF TRUST to ASSIGNEE on October 26, 2012;

WHEREAS, the DEED OF TRUST granted to ASSIGNEE a security interest in and to the MARKS and certain other collateral, which security interest was perfected by a duly filed UCC financing statement;

WHEREAS, ASSIGNEE hereby states that ASSIGNOR has defaulted under its obligations owing to ASSIGNEE under the NOTES and the DEED OF TRUST;

WHEREAS, under the DEED OF TRUST, ASSIGNOR has irrevocably appointed ASSIGNEE as ASSIGNOR’s true and lawful attorney-in-fact, with full power and authority in the place and stead of ASSIGNOR and in the name of ASSIGNOR, after the occurrence and during the continuance of an event of default of ASSIGNOR’s obligations to ASSIGNEE, for the purpose of effectuating any sale, assignment, transfer or delivery for the enforcement of the DEED OF TRUST, to execute and deliver all such deeds, assignments, bills of sale and other instruments (without recourse, warranty or representation of any kind) as ASSIGNEE may consider necessary or appropriate (such power, the “POWER OF ATTORNEY”);

WHEREAS, ASSIGNEE has exercised its post-default remedies pursuant to the provisions of Nevada Revised Statutes 104.9604(1)(b) and other applicable law, by selling the MARKS at a unified foreclosure sale, whereby ASSIGNEE credit-bid certain of the obligations owing by ASSIGNOR to ASSIGNEE, and ASSIGNEE was the prevailing bidder;

WHEREAS, by reason of the exercise of such remedies, ASSIGNEE has acquired the rights of the ASSIGNOR in the MARKS;

NOW, THEREFORE, for the avoidance of doubt and in consideration of ASSIGNEE’s credit-bid amount at such public disposition and other good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which hereby is acknowledged, and pursuant to the POWER OF ATTORNEY, ASSIGNOR, by and through ASSIGNEE as its attorney-in-fact, does hereby acknowledge, ratify and confirm that it has sold, assigned, transferred and conveyed unto ASSIGNEE its entire right, title and interest in and to the MARKS, and to the applications and/or registrations for the MARKS, together with the goodwill of the business symbolized by the MARKS and the portion of the business of the ASSIGNOR to which the MARKS pertain, including the right to sue and recover for any past infringement thereof.


