## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “**Release**”) is made as of June 26, 2019, by BANK OF AMERICA, N.A., as collateral agent for the Secured Parties (in such capacity, “**Collateral Agent**”), in favor of the Persons set forth on Exhibit I (each, a “**Grantor**” and collectively, the “**Grantors**”). Capitalized terms used but not defined herein have the meanings given to them (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantors and Collateral Agent are party to (i) that certain Security Agreement, dated as of May 8, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), and (ii) that certain Intellectual Property Security Agreement, dated as of May 8, 2018 (the “**IP Security Agreement**”), whereby each Grantor granted to Collateral Agent for the benefit of the Secured Parties a security interest in and continuing lien on such Grantor’s right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time thereafter may have acquired any right, title or interest (collectively, the “**IP Collateral**”):

- (a) the issued and pending Patents in the USPTO set forth in Schedule A hereto, together with all divisionals, continuations, continuations-in-part, reissues, reexaminations, and extensions thereof, and all income, royalties, proceeds and Liabilities at any time due or payable or asserted under or with respect to any of the foregoing or otherwise with respect to such Patents, including all rights to sue or recover at law or in equity for any past, present or future infringement, violation or other impairment thereof, and, in each case, all rights to obtain any other of the foregoing rights;
- (b) the registered Trademarks and Trademarks for which applications are pending in the USPTO set forth in Schedule B hereto, together with all renewals thereof, and all income, royalties, proceeds and Liabilities at any time due or payable or asserted under or with respect to any of the foregoing or otherwise with respect to such Trademarks, including all rights to sue or recover at law or in equity for any past, present or future infringement, dilution, violation or other impairment thereof, and, in each case, all rights to obtain any other of the foregoing rights (but excluding any United States “intent-to-use” trademark application prior to the filing and acceptance of a “Statement of Use” or “Amendment to Allege Use” with respect thereto, to the extent, if any, that, and solely during the period, if any, in which, the grant, attachment or enforcement of a Security Interest hereunder would impair the validity or enforceability of such intent-to-use trademark application or any registration issuing therefrom under applicable federal law); and
- (c) the registered Copyrights in the USCO set forth in Schedule C hereto, together with all reversions, renewals and extensions thereof, and all income, royalties, proceeds and Liabilities at any time due or payable or asserted under or with respect to any of the foregoing or otherwise with respect to such Copyrights, including all rights to sue or recover at law or in equity for any past, present or

future infringement, violation or other impairment thereof, and, in each case, all rights to obtain any other of the foregoing rights;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on May 29, 2018, at Reel/Frame 046248/0465 (Intermedix Office Based, LLC Patents), at Reel/Frame 046248/0492 (Intermedix Corporation Patents), at Reel/Frame 046248/0546 (R1 RCM Inc. Patents), at Reel/Frame 6337/0148 (Advanced Data Processing, Inc. Trademarks), at Reel/Frame 6337/0188 (Medical Consultants, Inc. Trademarks), at Reel/Frame 6391/0866 (Intermedix Office-Based, LLC Trademarks), at Reel/Frame 6337/0225 (Intermedix ARM, LLC Trademarks), at Reel/Frame 6337/0275 (Intermedix Corporation Trademarks), and at Reel/Frame 6337/0657 (R1 RCM Inc. Trademarks), and with the United States Copyright Office (the “USCO”) on May 30, 2018 at Volume 9957, Doc. No. 243; and

WHEREAS, the Grantors have requested that Collateral Agent execute and deliver this Release to evidence the release of its security interest in the IP Collateral for filing and recordation with the USPTO and USCO.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent (on behalf of itself and the other Secured Parties), without any representation, warranty or recourse of any kind or nature, hereby releases and terminates its security interest in and lien on the IP Collateral, and re-assigns and re-conveys to the Grantors (as applicable) any and all right, title or interest Collateral Agent may have in or to the IP Collateral.
