CLASS 1: Chemicals used in industry, science and photography, as well as in agriculture, horticulture and forestry except fungicides, herbicides, insecticides and parasiticides; unprocessed artificial resins, unprocessed plastics; manures; fire extinguishing compositions; tempering and soldering chemical preparations; chemical preparations for preserving foodstuffs; adhesives for use in industry

CLASS 2: Paints, varnishes, lacquers; preservatives against rust and against deterioration of wood in the nature of a coating; colorants; wood mordants; raw natural resins; metals in foil and powder form for use in painting, decorating, printing and art

CLASS 7: Machines, namely, machines for generating electricity and gypsum from waste gases; oil refining machines; natural gas refining machines; current generators; condensing installations, namely, air-cooled condensers comprised of fans, heat exchangers, condensers, and valves; turbines, namely, hydraulic turbines, other than for land vehicles; motors and engines except for land vehicles; machine coupling and transmission components except for land vehicles

CLASS 8: Hand tools and hand-operated implements, namely, spatulas, drywall hawks, Hand-operated telescopic arm for fixing panels of plaster on wood or walls and ceilings

CLASS 9: Measuring apparatus and instruments, namely, level gauges, angle gauges, length measuring gauges; apparatus for recording, transmission or reproduction of sound or images; blank magnetic data carriers, blank recordable optical disc; mechanisms for coin-operated apparatus; cash registers, calculating machines, data processing equipment and computers; fire-extinguishing apparatus

CLASS 11: Apparatus for lighting, heating, steam generating, cooking, refrigerating, drying, ventilating, water supply and sanitary purposes, namely, lighting apparatus, namely, lighting installations; steam generating installations; heating systems for residential and commercial buildings comprised of boilers, valves, pipes, manifolds, control panel switches, and electrical wire, all sold as a unit

CLASS 16: Paper, cardboard; printed matter, namely, magazines, manuals featuring building construction and drywall systems; paint brushes; printed instructional and teaching material in the field of building construction, and drywall systems, except apparatus

CLASS 17: Plastics in extruded form for use in further manufacture; packing, stopping and insulating materials; flexible pipes, not of metal

CLASS 20: Furniture, mirrors, picture frames; goods of wood, cork, reed, cane, wicker, shell, amber, mother-of-pearl, meerschaum and substitutes for all these materials, or of plastics, namely, non-metal profiles for arranging devices on and in walls, ceilings and other surfaces

CLASS 27: Carpets, rugs, mats and matting, linoleum and other materials, namely, rubber, plastic, textiles, all for covering existing floors; non-textile wall hangings

CLASS 37: Building construction; repair of buildings; installation of building insulation, installation of drywall panels

REQUIREMENTS TO MAINTAIN YOUR FEDERAL TRADEMARK REGISTRATION

WARNING: YOUR REGISTRATION WILL BE CANCELLED IF YOU DO NOT FILE THE DOCUMENTS BELOW DURING THE SPECIFIED TIME PERIODS.

Requirements in the First Ten Years*

What and When to File:

- **First Filing Deadline:** You must file a Declaration of Use (or Excusable Nonuse) between the 5th and 6th years after the registration date. See 15 U.S.C. §§1058, 1141k. If the declaration is accepted, the registration will continue in force for the remainder of the ten-year period, calculated from the registration date, unless cancelled by an order of the Commissioner for Trademarks or a federal court.
- **Second Filing Deadline:** You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between the 9th and 10th years after the registration date.* See 15 U.S.C. §1059.

Requirements in Successive Ten-Year Periods*

What and When to File:

- You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between every 9th and 10th-year period, calculated from the registration date.*

Grace Period Filings*

The above documents will be accepted as timely if filed within six months after the deadlines listed above with the payment of an additional fee.

***ATTENTION MADRID PROTOCOL REGISTRANTS:** The holder of an international registration with an extension of protection to the United States under the Madrid Protocol must timely file the Declarations of Use (or Excusable Nonuse) referenced above directly with the United States Patent and Trademark Office (USPTO). The time periods for filing are based on the U.S. registration date (not the international registration date). The deadlines and grace periods for the Declarations of Use (or Excusable Nonuse) are identical to those for nationally issued registrations. See 15 U.S.C. §§1058, 1141k. However, owners of international registrations do not file renewal applications at the USPTO. Instead, the holder must file a renewal of the underlying international registration at the International Bureau of the World Intellectual Property Organization, under Article 7 of the Madrid Protocol, before the expiration of each ten-year term of protection, calculated from the date of the international registration.
