Hello, my name is Tim Schimpf and I am an examining attorney with the U.S. Patent and Trademark Office. I am reviewing the trademark application for BANDIT and BANDIT THE BEAST, Serial Nos. 88162663, 88162667, 88162674, 88162677, and 88162670. There are a few issues I'd like to discuss with you about the applications.

Identification of Goods: The wording of the identifications need to be amended to specify the type of wood processing conducted by the machines. Based on applicant's prior registrations and applicant's website, I suggest amending the identifications to:

Serial Nos. 88162663, 88162667, 88162674, 88162677:

"Industrial machinery, namely, wood and brush chipping machines and tree stump cutters" in International Class 7.

Serial No. 88162670:

"Industrial machinery, namely, horizontal grinders used for shredding wood and other waste" in International Class 7.

Disclaimer for Serial No. 88162670: Applicant has identified waste processing services. The recycling symbol in the mark is a universal symbol indicating the goods involve recycling or are otherwise environmentally friendly. As this symbol is descriptive, applicant must provide a disclaimer statement. With applicant's permission, I will add the following statement to the record:

No claim is made to the exclusive right to use the recycling symbol apart from the mark as shown.

Advisory - Prior Pending Applications: U.S. Application Serial No. 87933451 for BANDIT and its co-pending application Serial No. 87933488 were filed before the current application for broad machinery goods that would include applicant's machinery. If the applications register, the current application may be refused registration under Trademark Act Section 2(d) because of a likelihood of confusion between the marks. I am aware of applicant's prior registration for machinery in Class 7, but these prior pending application may still cause confusion. But, if the prior application does not register, there will be no conflict with the current application. Applicant will need to wait until the prior application is resolved. This is an advisory statement only, applicant does not need to take any action at this time. If the above issues are resolved, the current application will be suspended pending the outcome of that prior application.

Please respond by **Thursday**, **January 31** as to whether applicant agrees to the amendments in #1 and #2. If applicant agrees, I can make the amendments through an examiner's amendment and suspend the application pending the result of the prior pending applications.
