There is one issue we can fix via email or over the phone that is preventing approval of the application for the next step of the registration process; the identification of services remains indefinite and amendment is required.

1. Identification of Services

Class 42

The wording "Information technology process automation non-downloadable software for information technology support, namely, data analysis, monitoring, performing diagnostic testing, and identifying and correcting problems with computer network systems" in the identification of services is indefinite and must be clarified because as written the identification of services may include goods or services. TMEP 1301.01. Applicant must specify that the non-downloadable software is provided on-line, is web-based, or is provided on a temporary basis. Without such specification, the wording " non-downloadable software" is broad enough to encompass Class 9 recorded software that is non-downloadable. *See* 37 C.F.R. §2.32(a)(6); TMEP §1402.01.

Applicant may substitute the following wording, if accurate:

"Information technology process automation **web-based** non-downloadable software for information technology support, namely, data analysis, monitoring, performing diagnostic testing, and identifying and correcting problems with computer network systems."
