CLASS 1: chemicals used in industry; glazing putty, spatula putty being glaziers' putty; sealants being chemicals for sealing of surfaces, namely, surface sealants for use in construction, roofing, plumbing, glazing and waterproofing; industrial adhesives for use in filling surface blemishes; chemicals used in industry in the nature of fillers for maintenance and repair used in construction, roofing, plumbing, glazing and waterproofing; adhesives for industrial purposes, namely, for billposting, and for mending broken articles not for medical, household or stationery use; adhesives for construction use; adhesives for paper hanging, and for wall tiles; chemical preparations, namely, sprays, gels, powders to prevent odours, mould, mildew from growing; mould inhibiting chemicals for preventing growth of mold; products for sealing surfaces, brickwork, concrete, other than paints and oils, namely, chemical sealants; water sealant preparations, namely, chemical grout sealants; acrylic monomers for use as sealants, ethyl urethane floor sealants; grout sealants in the nature of chemical preparations

CLASS 3: Cleaning, polishing, scouring, and abrasive preparations; un-medicated soaps, namely, sugar soap; oven cleaners; barbecue grill cleaning preparations; cleaning and protective preparations to clean surfaces and provide protective coatings to repel grease, grime, dirt; degreasers other than for use in manufacturing processes; paint removing preparations; cloths, pads and wipes impregnated with cleaning, polishing, scouring and abrasive preparations for household use; polishing, preserving, and protective cleaning preparations, for use on textiles, leather, fabric

CLASS 4: All purpose lubricants, namely, anti-corrosive lubricants; lubricants for use on household items, namely, lubricants having cleaning properties; lubricating oils and greases; industrial oils, namely, oils for sealing brickwork, concrete, slate, surfaces

CLASS 5: Disinfectants; fungicides; deodorising and air purifying preparations; preparations to destroy vermin and insects; antimicrobial and antibacterial preparations, namely, coatings, sprays, powders and gels to treat mould; antimicrobial preparations to treat mould growth on indoor, outdoor and product surfaces; cleaning cloths impregnated with disinfectant for hygiene purposes, namely, sanitizing wipes; wipes for hygienic purposes, other than impregnated with cleaning preparations, namely, odor-neutralizing wipes for hair and clothing

CLASS 8: Hand tools and implements, namely, paint edgers, paint scrapers, window scrapers, putty trimming knives, and blades for wallpaper scourers, wallpaper scissors and shears; sanding blocks; adhesive spreaders, namely, painting knives, palette knives; non-electric caulking guns; blades for manually operated tools, namely, filling blades; hobby knives, hand

tools as painting accessories and paint applicators, namely, paint trim guides and paint scrapers; hand operated coating apparatus, namely, a beveled squeegee for spreading and leveling paints; paint stripping apparatus, namely, paint scrapers; hand tool for cleaning paint roller covers; hand-operated hand tools and garden tools, namely, spreaders for seed fertilizer and dry lawn chemicals

CLASS 16: Printed matter, namely, guides, brochures, instructional material and educational material in the field of home repair, home renovation and DIY products; printed publications, namely, books, hand-outs, and workbooks in the fields of DIY products; stationery; adhesives for stationery or household purposes; paint brushes; paint rollers; painting accessories, namely, paint roller covers and paint roller handles; paper for cleaning purposes, not impregnated with cleaning preparations; paper tissues for cleaning, not impregnated with cleaning preparations; paint stirrers

CLASS 17: expansion joint fillers and fillers for repairing cracks in building structures; sealants for buildings; sealing putty being non-permanent sticky putty for sealing purposes; sealant compounds for joints; chemical compositions for repairing leaks; construction mastics in the nature of sealants for joints and caulking compounds in ceiling, wall, and floor tiles; waterproof packing material for forming seals to fill gaps or joints in building structures for the purpose of preventing water entry; waterproof sealant in the form of pastes that cure to form flexible bonds, utilised to fill gaps or joints in building structures for the purpose of preventing water entry; plastic film for packing purposes other than for wrapping; insulating substances for insulating buildings against moisture; expansion joint fillers; flexible fillers for expansion joints and flexible fillers for repairing cracks in building structures, adhesive sealant and caulking compounds; semi-processed artificial resins and plastics used as insulating fillers; elastomeric sealants for filling cracks in buildings, elastomeric sealants for plugging gaps in buildings

**REQUIREMENTS TO MAINTAIN YOUR FEDERAL TRADEMARK REGISTRATION**

**Requirements in the First Ten Years\***

**What and When to File:**

- **First Filing Deadline:** You must file a Declaration of Use (or Excusable Nonuse) between the 5th and 6th years after the registration date. See 15 U.S.C. §§1058, 1141k. If the declaration is accepted, the registration will continue in force for the remainder of the ten-year period, calculated from the registration date, unless cancelled by an order of the Commissioner for Trademarks or a federal court.
- **Second Filing Deadline:** You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between the 9th and 10th years after the registration date.\* See 15 U.S.C. §1059.

**Requirements in Successive Ten-Year Periods\***

**What and When to File:**

- You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between every 9th and 10th-year period, calculated from the registration date.\*

**Grace Period Filings\***

The above documents will be accepted as timely if filed within six months after the deadlines listed above with the payment of an additional fee.

**\*ATTENTION MADRID PROTOCOL REGISTRANTS:** The holder of an international registration with an extension of protection to the United States under the Madrid Protocol must timely file the Declarations of Use (or Excusable Nonuse) referenced above directly with the United States Patent and Trademark Office (USPTO). The time periods for filing are based on the U.S. registration date (not the international registration date). The deadlines and grace periods for the Declarations of Use (or Excusable Nonuse) are identical to those for nationally issued registrations. See 15 U.S.C. §§1058, 1141k. However, owners of international registrations do not file renewal applications at the USPTO. Instead, the holder must file a renewal of the underlying international registration at the International Bureau of the World Intellectual Property Organization, under Article 7 of the Madrid Protocol, before the expiration of each ten-year term of protection, calculated from the date of the international registration.
