The term GAME must be disclaimed

**90124287 stylized TSR mark**

Class 28 identification: equipment sold as a unit for playing role playing and/or parlor games games;

· Here, the "and/or" should be amended to "AND" because the applicant identified two different types of games and the equipment wouldn't necessarily be the same equipment, so it should be clear that it is both (not just one or the other).

· the duplicate "games" deleted (created by the format of the identification in the ID Manual and what applicant inserted).
