Dear Mr. Hughes and Mr. Lauter,

I am the assigned trademark examiner for the above-referenced application. I have reviewed the application and there are several potential issues that can be resolved with an amendment to the identification, similar to the one that was made in applicant's previous application for the word mark CONNECT, Serial No. 90644740. In addition, a slight amendment to the mark description is required.

As to the identification, I suggest the following amendments:

Class 29: Sunflower oil for food; sunflower seeds, prepared; sunflower seed-based snack foods; none of the foregoing comprised of any oils, extracts or ingredients from Cannabis sativa L; hemp seed based food, namely, hemp seed oil; sunflower seed-based snack foods containing hemp seeds and hemp seed oil

Class 30: Wheat-based snack foods; corn-based snack foods; barley-based snack foods; cereal-based snack foods; sorghum-based snack foods; breakfast cereals; flour; processed wheat; barley meal; processed sorghum;

bread; none of the foregoing comprised of any oils, extracts or ingredients from Cannabis sativa L; wheat-based snack foods containing hemp seeds and hemp seed oil; corn-based snack foods containing hemp seeds and hemp seed oil; barley-based snack foods containing hemp seeds and hemp seed oil; cereal-based snack foods containing hemp seeds and hemp seeds and hemp seeds and hemp seeds and hemp seed oil

Class 32: Beer; non-alcoholic beer flavored beverages; none of the foregoing comprised of any oils, extracts or ingredients from Cannabis sativa L

This amendment is necessary to avoid potential unlawful use refusals under the Controlled Substances Act and the Food, Drug, and Cosmetic Act and to properly classify the sunflower seed based products. The deletion of "non-alcoholic carbonated beverages" from class 32 will also avoid a Section 2(d) refusal for likelihood of confusion with Reg. No. 6038883 (SODASTREAM CONNECT).

As to the mark description, I believe the following would more accurately describe the mark: "The mark consists of the word CONNECT in a **pointed oval** where the upper half of the **oval** is in white and contains a **sprout with three leaves** and the bottom half of the **oval** is shaded in black and contains the **plant**'s root."

If you agree that the changes are acceptable, we can move more quickly through the registration process for this application. **Please contact me by email or phone by 1 PM EST on Tuesday, January 17, 2023,** if you agree to allow me to correct the above by examiner's amendment.
