**The following issue must be addressed before the mark can be approved for publication:**

**Clarification to Amended Identification of Goods**

The response makes it clear that the goods are specifically for fire protection use and are meant to prevent flames from entering into attic and crawl spaces. To clarify the purpose of the goods and as provided in applicant's response to the Section 2d refusal in this matter, the following amendments are suggested (see suggestions in bold):

*"Metal flame and ember resistant vents, **flame-resistant** vent screens, and vent covers, all for **fire protection use in attic and crawl spaces** ~~vents~~ **to prevent flames and burning embers from entry into homes**"* in International Class 6.
