I am the trademark examining attorney assigned to application no. 97081110 for the mark "BEAUTYSPAN". I have conducted a preliminary review of the application and will require an identification amendment.

First, applicant is advised to delete or modify the duplicate entries in the identification of goods in International Class 003 for "*cosmetic creams for skin care,*" "*cosmetic preparations for skin care,*" and "*non-medicated skin care preparations, namely, creams, lotions, gels, toners, cleaners and peels.*"

Additionally, the following amended identification of goods is suggested, if accurate:
