I have consulted with my senior attorney and adding "accessories thereto" would not be sufficient.

However, consistent with your suggestion, would the following supplemental wording in bold print be acceptable:

- **Class 009:** Downloadable virtual goods, namely, computer programs featuring footwear **and footwear accessories**, clothing **and clothing accessories**, headwear **and headwear accessories**, eyewear **and eyewear accessories**, bags **and bag accessories**, sports bags **and sports bag accessories**, backpacks **and backpack accessories**, sports equipment **and sports equipment accessories**, art **and art accessories**, toys **and toy accessories** for use online and in online virtual worlds

- **Class 035:** Retail store services featuring virtual goods, namely, footwear **and footwear accessories**, clothing **and clothing accessories**, headwear **and headwear accessories**, eyewear **and eyewear accessories**, sports bags **and sports bag accessories**, backpacks **and backpack accessories**, sports equipment **and sports equipment accessories**, art **and art accessories**, toys **and toy accessories** for use online and in online virtual worlds; on-line retail store services featuring virtual merchandise, namely, featuring footwear **and footwear accessories**, clothing **and clothing accessories**, headwear **and headwear accessories**, eyewear **and eyewear accessories**, bags **and bag accessories**, sports bags **and sports bag accessories**, backpacks **and backpack accessories**, sports equipment **and sports equipment accessories**, art **and art accessories**, toys **and toy accessories** for use online and in online virtual worlds

- **Class 041:** Entertainment services, namely, providing on-line, non-downloadable virtual footwear **and footwear accessories**, clothing **and clothing accessories**, headwear **and headwear accessories**, eyewear **and eyewear accessories**, bags **and bag accessories**, sports bags **and**
