I am the examining attorney for BS SN 97206578. The identification is indefinite and overbroad. I would suggest the following, if accurate in Class 25:

Sweatshirts; T-shirts; Drawers **as clothing**; Hoodies; Tank-tops; **Clothing** Belts; Bottoms **as clothing**; **baseball** Caps; Graphic T-shirts; Hooded sweatshirts; Jackets **as clothing**; Tops, **namely, t-shirts**

Additionally, the mark description needs amendment. I would suggest the following, if accurate "The mark consists of a wavy line forming a capitalized letter B in a cursive style on top of a capitalized letter S joined together. The vertical bar on the "B" is not complete and there is a single dot near the center of the letter "B". The letter "B" appears above the letter "S".
