I have reviewed the Response to Office Action, and there is one small issue that can be corrected without the need for a Final Office Action. I mistakenly included the wording "featuring" in my proposed amendment in Class 41 ("entertainment services, namely, providing on-line, nondownloadable virtual <u>featuring</u> footwear, clothing, bags, clothing accessories and charms for decorating footwear, clothing, bags and clothing accessories"), which is unclear. Similarly, for the sake of clarity, the purpose of applicant's goods also is required.
