Good morning,

I am reviewing Serial No. 97854117 (HARLEY-DAVIDSON). In review of this application there is one issue that can be corrected without the necessity of an Office action.

Identification of Goods

First, we require an amended identification of the goods in International Class 025 because the wording “jackets” is indefinite and overbroad. Specifically, it is unclear whether applicant is offering “Clothing Jackets” in Class 025, “Life jackets” in Class 009, “Strait jackets” in Class 10, or “Book jackets” in Class 16.

I propose the following amended Identification of Goods, with suggested changes in bold:

Class 025: **T-shirts;Sweatshirts;Tank tops;Pants;Hats;Clothing jackets;Vests**
