I am the trademark examining attorney handling the trademark application for BEST MAN & Design, Serial No. 97861849. I have reviewed this application and there are a couple of issues that can be corrected without the necessity of an Office action. Please see below:

MARK DESCRIPTION

An amended description of the mark and color claim is required for completion and clarity. The suggested description of the mark would read as follows, with suggested changes in bold:

Mark Description: The mark consists of the wording "~~Best Man~~" "**BEST MAN**" in stylized format with a ~~shirt~~ **men's suit** background.

DISCLAIMER

The term "BEST MAN" must be disclaimed, for the following services, because it describes the use of the services, and other entities use – and must remain free to use – the term to describe similar services: .

If you approve the amendment, the following disclaimer will be added to the record:

No claim is made to the exclusive right to use "BEST MAN" for "On-line retail department store services; On-line retail gift shops; On-line retail store services featuring a wide variety of consumer goods of others; On-line wholesale and retail store services featuring clothing and jewelry; Online advertising and marketing services in the field of clothing and jewelry; Provision of an online marketplace for buyers and sellers of goods and services; Retail department store services; Retail department stores; Retail gift shops; Retail store services featuring a wide variety of consumer goods of others; Retail store services featuring clothing and jewelry; Retail variety stores; The bringing together, for the benefit of others, of clothing, excluding the transport thereof, enabling customers to conveniently view and purchase those goods by means of on-line retail stores; Wholesale and retail store services featuring clothing and jewelry" apart from the mark as shown.
