VAN CAMP represents and warrants that it will cooperate in any actions necessary for TRI-UNION to prosecute, renew or register its rights, title and interests in and to the Marks, including United States and foreign registrations, and to cooperate in any actions brought to enforce the rights accompanying this assignment against third parties.
