

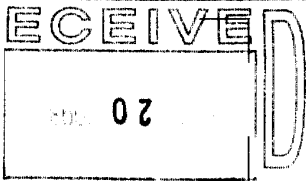

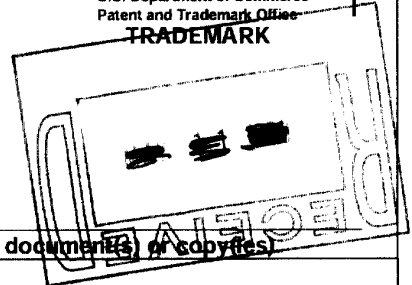

RELEASE OF INTELLECTUAL PROPERTY

Release of Intellectual Property (the "Release"), dated as of April 14, 1998, made by CREDIT AGRICOLE INDOSUEZ (formerly known as Banque Indosuez, New York Branch), as Collateral Agent ("Collateral Agent"), in favor of SCHRADER-BRIDGEPORT INTERNATIONAL, INC. ("Pledgor").

R E C I T A L S :

A. Schrader Automotive Inc. ("Schrader") and Collateral Agent entered into a Subsidiary Intellectual Property Security Agreement, dated as of February 16, 1995, recorded as to patents in the U.S. Patent and Trademark Office (the "PTO") on February 27, 1995 at Reel 7541, Frame 0955, recorded as to trademarks in the PTO on February 27, 1995 at Reel 1323, Frame 361, and recorded as to copyrights in the U.S. Copyright Office (the "Copyright Office") on February 23, 1995 at Volume 3087, Page 117, which agreement was amended by Amendment No. 1 dated as of April 30, 1996, recorded as to patents in the PTO on May 9, 1996, at Reel 7803, Frame 0659, recorded as to trademarks in the PTO on May 9, 1996 at Reel 1432, Frame 0796, and recorded as to copyrights in the Copyright Office on May 3, 1996 at Volume 3234, Page 252 (as amended, the "Schrader Agreement").

B. Bridge Products, Inc. ("Bridge") and Collateral Agent entered into a Subsidiary Intellectual Property Security Agreement, dated as of April 30, 1996, recorded as to patents in the PTO on May 2, 1996 at Reel 7795, Frame 0414, and recorded as to trademarks in the PTO on May 2, 1996 at Reel 1431, Frame 0327 (the "Bridge Agreement").

C. In order to consolidate, amend and restate each of the Schrader Agreement and the Bridge Agreement, Pledgor (as successor by merger to Schrader and Bridge) and Collateral Agent entered into a certain Consolidated, Amended and Restated Subsidiary Intellectual Property Security Agreement, dated as of September 4, 1996 and recorded as to Patents in the Patent Office on September 16, 1997 at Reel 8006, Frame 462, recorded as to trademarks in the Patent Office on September 16, 1996 at Reel 1476, Frame 335 and recorded as to copyrights in the Copyright Office on September 11, 1996 at Volume 3278, Page 451 (the "Agreement"; capitalized terms used and not defined herein shall have the meanings set forth in the Agreement). Pursuant to the Agreement, Pledgor granted to Collateral Agent a lien on

and security interest in certain Pledged Collateral owned by Pledgor.


D. In accordance with the terms of the Agreement, Pledgor has satisfied all of its outstanding obligations under the Agreement, and in connection therewith, Pledgor has requested and Collateral Agent and the Secured Parties have agreed to release their lien on all Pledged Collateral pledged pursuant to the Agreement.

A G R E E M E N T :

Collateral Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Pledgor pursuant to the Agreement in all Pledged Collateral, including, without limitation, (i) the Patents identified on Schedule A annexed hereto, (ii) the Trademarks identified on Schedule B annexed hereto, (iii) the Copyrights identified on Schedule C annexed hereto and (iv) the Licenses identified on Schedule D annexed hereto (collectively, the "Released Collateral"), and all liens, security interests, charges or other encumbrances in favor of Collateral Agent in the Released Collateral shall hereby terminate and revert to Pledgor and all right, title and interest of Collateral Agent in the Released Collateral will hereby cease, terminate and become void.


