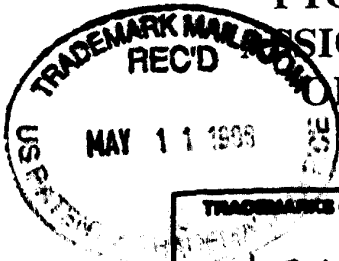

ASSIGNMENT OF INTELLECTUAL PROPERTY

SERVICE AND TRADEMARKS

This Assignment of Intellectual Property (hereafter, "Assignment") is made this March 30, 1998 by Reach Software Corporation, a Delaware corporation ("Seller"), having its principal place of business at 872 Hermosa Drive, Sunnyvale, CA 94086, to Responsys, Inc., a California corporation ("Buyer"), having its principal place of business at 872 Hermosa Drive, Sunnyvale, CA 94086.

RECITAL

Seller is the exclusive owner of all right, title to, and interest in those certain trademarks, trademark applications, service marks and service mark applications issued by (or pending before) by the United States Patent and Trademark Office, as set forth on Exhibit D(2)(a) hereto (hereafter, the "Trademarks").

2. Seller desires to transfer and assign all of its right, title to, and interest in the Trademarks to Buyer, and Buyer wishes to acquire the Trademarks.

AGREEMENT

NOW, THEREFORE, for the consideration set forth in the Asset Purchase Agreement dated as of March 30, 1998, by and between Seller and Buyer and other good and valuable consideration, the receipt of which is hereby acknowledged, Seller does hereby sell, assign, transfer and convey to Buyer all of its right, title and interest in and to the Trademarks, identified on Exhibit D(2)(a) hereto, together with the goodwill of the business symbolized by said Trademarks, and the registrations and applications for registration thereof, as specified on Exhibit D(2)(a) hereto, together with any and all causes of action for infringement of the Trademarks.

Seller will do what ever is reasonably necessary for Buyer to fully secure its interest in and to the Trademarks and the registrations and the applications for registration thereof and to enforce its rights therein.


