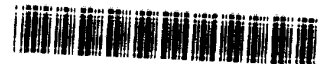



FIRST: That pursuant to a written consent in lieu of a meeting of the Board of Directors of this Corporation, the Board adopted a resolution setting forth a proposed amendment of the Certificate of Incorporation of this Corporation. The resolution setting forth the proposed amendment is as follows:

"RESOLVED, that the following amendment of the Certificate of Incorporation of this Corporation is hereby adopted and approved:

"Article 1 shall be amended in its entirety to read as follows:

"1. The name of this corporation is Superior Fireplace Company."
