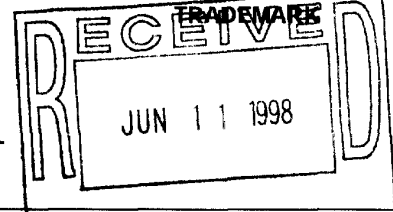




CERTIFICATE OF AMENDMENT
