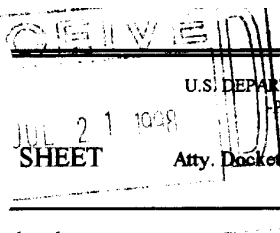

CHANGE OF ADDRESS OF ASSIGNEE

An assignment was recorded in the Patent and Trademark Office for the above-identified trademark registrations on March 16, 1993, at Reel 0944, Frame 0063 in which the above-identified trademark registration were transferred from General Signal Corporation to Ultratech Stepper, Inc.

At the time of that Assignment Ultratech Stepper, Inc. was located at 3230 Scott Boulevard, Santa Clara, CA 95054.

Then a change of address was recorded on June 19, 1995, at Reel 1417 and Frame 0235 in which it was intended that the address for Ultratech Stepper, Inc. would be changed for each of the above-identified trademark registrations to 3050 Zanker Road, San Jose, CA 95134.

It has recently been brought to our attention by the Attorneys for Electrolux Corporation that the final digit of one of the registration numbers for which we endeavored to change the address of the registration owner was in error. Thus, the change of address for Ultratech Stepper, Inc. was recorded against a registration which does not belong to Ultratech Stepper, Inc.

Further we have been informed by the Attorneys for Electrolux that they were instructed by the Patent Office to request that we file a corrected change of address to replace the one recorded on June 19, 1995.

The enclosed Trademark Recordation Form Cover Sheet and this Change of Address have been so corrected.

The registration number that was in error on the form recorded in 1995 was that for the mark "ULTRATECHSTEPPER". The incorrect registration number 1,617,477 which is for the mark

"ELECTROLUX" was on the forms in 1995, the **correct registration number 1,617,470 which is for "ULTRATECHSTEPPER"** is the number included in these corrected documents.

All three of the other registration numbers that were in the forms in 1995 are correct.

Please make the necessary corrections to remove the change of address against the "ELECTROLUX" mark that was in error and enter the change of address for Ultratech Stepper, Inc. against the registration for "ULTRATECHSTEPPER", namely 3050 Zanker Road, San Jose, CA 95134.
