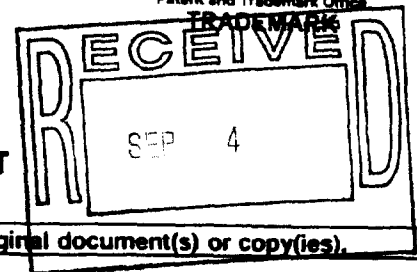

TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of this 5th day of May, 1998 ("Effective Date"), by and between Raytheon Commercial Laundry LLC, a Delaware limited liability company, with its principal office at Post Office Box 990, Ripon, Wisconsin 54971-0990 ("Assignor"), and Alliance Laundry Systems LLC, a Delaware limited liability company, with its principal office at Post Office Box 990, Ripon, Wisconsin 54971-0990 ("Assignee").

WHEREAS, Assignor has entered into an Agreement and Plan of Merger (the "Agreement"), dated as of February 21, 1998, by and among Bain/RCL, L.L.C., a Delaware limited liability company ("Bain/RCL"), RCL Acquisitions, L.L.C., a Delaware limited liability company ("MergeCo"), Assignor and Raytheon Company, a Delaware corporation ("Raytheon"), pursuant to which MergeCo, a transitory merger company formed by Bain/RCL, will merge with and into Assignor, a wholly-owned subsidiary of Raytheon (the "Merger");

WHEREAS, pursuant to the Agreement, Assignor has agreed to assign all of its assets, properties and rights to Assignee, which such assignment shall be deemed to occur simultaneously with the Merger;

WHEREAS, Assignor is the sole and exclusive owner of the entire right, title and interest in, to and under the trademarks and the United States trademark registrations and applications for registration identified and set forth on Schedules A and B, respectively, including variations thereof, and the unregistered trademarks and domain names identified and set forth on Schedule C, and any variations thereof, and the foreign trademark registrations and applications for registration identified and set forth on Schedule D (collectively, the "Marks"), and the goodwill of the business associated therewith.

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign all right, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, simultaneously with the Merger, its entire right, title and interest in and to the Marks together with all goodwill associated therewith, and all registrations and applications therefor, in the United States and all foreign countries, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States and all foreign countries, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made, together with all income, royalties, damages and payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages and payments by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner thereof.

Assignor hereby represents and warrants that its right, title and interest in and to the Marks set forth in Schedules A, B, C and D are free and clear of any liens and encumbrances, that it has full right to assign all of its interests therein, and that it has not executed and will not execute any agreement or other instrument in conflict herewith. Assignor shall use its best efforts to obtain all third party and governmental consents and approvals necessary to assign all of its rights, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used to Assignee. To the extent that the assignment hereunder by Assignor to Assignee is not permitted or not permitted without the consent of any other party, this Assignment shall not be deemed to constitute an assignment of the rights, title and interest in and to such Marks or the goodwill of the business in connection with which such Marks are used if such consent is not given or if such assignment otherwise would constitute a breach, and Assignee shall assume no rights, title and interest in and to such Marks or the goodwill of the business in connection with which such Marks are used.

Assignor shall provide to Assignee, its successors, assigns or other legal representatives, cooperation and assistance at Assignee's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required): (1) in the preparation and prosecution of any application for registration or any application for renewal of a registration covering any of the Marks; (2) in the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the Marks, including, but not limited to, testifying as to any facts relating to the Marks assigned herein and this Assignment; (3) in obtaining any additional trademark protection for the Marks that Assignee reasonably may deem appropriate

that may be secured under the laws now or hereafter in effect in the United States or for all foreign countries; and (4) in the implementation or perfection of this Assignment.
