WHEREAS, The Lovable Company, a Georgia corporation (the "Company"), owned the patents described in the attached <u>Schedule A</u> (the "Patents"), trademarks described in the attached <u>Schedule B</u> (the "Trademarks") and copyrights described in the attached <u>Schedule C</u> (the "Copyrights") (hereinafter the Patents, Trademarks and Copyrights, collectively, the "Intellectual Property") for which there are recordings in the United States Patent, Trademark and Copyright Offices under the numbers set forth in the said attached schedules.

WHEREAS, the Company is the legal owner of 32,000 shares of common stock of The Lovable Company, Ltd., a Japan corporation, (the "Stock"), which Stock has been pledged to Foothill Capital Corporation ("Foothill") and which Stock was optioned to Sara Lee Corporation or its designee ("Sara Lee") pursuant to the Order of the Bankruptcy Court dated July 16, 1998, a copy of which is appended hereto as Exhibit 1 (the "Sale Order");

WHEREAS, on February 17, 1998, the Company filed a voluntary bankruptcy petition pursuant to 11 U.S.C. § 301, and is currently a debtor and debtor-in-possession pursuant to Title 11 of the United States Code (the "Bankruptcy Code") in Case No. 98-62880 (the "Bankruptcy Case") in the United States Bankruptcy Court for the Northern District of Georgia, Atlanta Division (the "Bankruptcy Court");

WHEREAS, pursuant to, inter alia, (i) that certain Loan and Security Agreement dated as of October 8, 1997 by and between the Company and Foothill (the "Loan Agreement") and the Loan Documents (as defined in the Loan Agreement) related thereto, (ii) that certain Trademark Security Agreement by and between the Company and Foothill dated as of October 8, 1997, (iii) that certain Stock Pledge Agreement by and between the Company and Foothill dated as of October 8, 1997, (iv) that certain Senior Secured Super-Priority Debtor-in-Possession Loan and Security Agreement dated as of February 18, 1998 by and between the Company and Foothill (the "DIP Loan Agreement") and the Loan Documents (as defined in the DIP Loan Agreement) related thereto, (v) that certain Trademark Security Agreement dated as of February 18, 1998 by and between the Company and Foothill, (vi) that certain Stock Pledge Agreement by and between the Company and Foothill dated as of February 18, 1998, and (vii) that certain Release by Secured Party dated as of October 9, 1997 and executed by Wachovia Bank, N.A., a successor by merger to First National Bank of Atlanta (as such agreements have been amended or restated from time to time, the "Agreements") the Company granted a security interest in certain Intellectual Property of the Company, including, without limitation, the Trademarks, in favor of Foothill, as well as a security interest in the Stock, to secure the payment and performance by the Company of certain of its obligations thereunder:

WHEREAS, certain of the Agreements were recorded in the Assignment Branch, United States Patent and Trademark Office on October 17, 1997, located on Trademark Reel 1644, Frame 0374 (the "Filings");

WHEREAS, pursuant to the Sale Order the Intellectual Property was sold to Sara Lee and the Stock was optioned to Sara Lee free and clear of all liens, claims, and other encumbrances as set forth therein pursuant to the Bankruptcy Code, including liens, claims, encumbrances, or other rights of Foothill pursuant to the Agreements, which liens, claims, encumbrances, or other rights attached solely to the proceeds of such sale; and

WHEREAS, as a result of and pursuant solely to the entry of, the Sale Order, Sara Lee desires that Foothill execute and Sara Lee (at Sara Lee's expense) record releases of the Filings.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the undersigned, upon receipt of the Purchase Price (as defined in the Sale Order) does hereby terminate its security interest and liens in, and claims and other rights to the extent they currently exist (except the right to receive the proceeds of the sale pursuant to the Sale Order), with respect to, and does release and assign to Sara Lee, all of Foothill's interest, to the extent it currently exists, in the Intellectual Property and the Stock, including, without limitation, the following with respect to the Intellectual Property and Stock (as applicable): (a) all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof to the extent that there is no conflict with the provisions of any license agreement, (c) all rights to sue for past, present and future infringements thereof to the extent that there is no conflict with the provisions of any license agreement, (d) to the extent permitted by law, all of Foothill's (and solely to the extent of Foothill's interest therein, the Company's) rights corresponding thereto throughout the world, (e) any additional patent license agreements with any other party in connection with the Patents; (f) any additional trademark license agreements with any other party in connection with the Trademarks; (g) any additional copyright license agreements with any other party in connection with the Copyrights; and (h) all goodwill associated with any of the foregoing. Foothill further agrees to execute and delivery to Sara Lee in recordable form any further or additional documents reasonably necessary or desirable to effectuate the terms of this Release and Assignment.

The releases on behalf of Foothill herein shall pertain to only those certain assets acquired by Sara Lee pursuant to the approval of the Sale Order.
