TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of the 6 day of November, 1998, by FLEET CAPITAL CORPORATION (formerly known as Shawmut Capital Corporation) (formerly known as Barclay's Business Credit, Inc.) (the "Secured Party") in favor of COMDIAL CORPORATION, a Delaware corporation (the "Grantor");

WITNESSETH:

WHEREAS, on February 1, 1994 the Grantor and the Secured Party executed a Security Agreement - Intellectual Property, which was recorded on February 24, 1994 in Reel 1111, Frame 0447, Office of the Commission of Patents and Trademarks, pursuant to which the Grantor granted the Secured Party a lien in and security interest upon certain trademarks and trademark registrations and applications of the Grantor as more particularly described on Exhibit A attached hereto (the "Trademarks"); and

This Trademark Release shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

IN WITNESS WHEREOF, the Secured Party has duly executed this Trademark Release as of the day and year first above written.

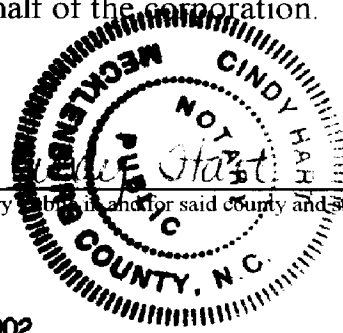
