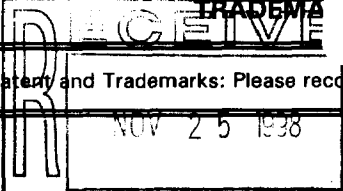

RELEASE OF SECURITY INTEREST
(TRADEMARK)

WHEREAS, CONGRESS FINANCIAL CORPORATION, having an address of 1133 Avenue of the Americas, New York, NY 10036 ("Congress"), and MERIT INDUSTRIES, INC., a Delaware corporation having an address of 2525 State Road, Bensalem, Pennsylvania 19020 ("Merit Industries"), entered into a Collateral Assignment of Trademarks (Security Agreement), (hereafter, the "Security Agreement") which was recorded in the U.S. Patent and Trademark Office on April 11, 1994 at Reel 1133, Frame 053;

WHEREAS, the conditions set forth in such Security Agreement have been satisfied; and

WHEREAS, the parties wish to evidence the satisfaction of the Security Agreement and the Release of the Security Interest in and to the trademarks identified in Schedule A (the "Collateral") and any other marks of Merit Industries in which Congress was granted a Security Interest and the goodwill associated with such marks, and wish to evidence the Release of the Security Interest in and to such Collateral by the recordation of a document in the U.S. Patent and Trademark Office and other offices;

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

i. Congress hereby releases its entire Security Interest in the Collateral identified in Schedule A, including any other marks of Merit Industries in which Congress was granted a Security Interest and the goodwill associated with such marks to the full extent that any Security Interest was granted in such Collateral by such Security Agreement.

ii. This Release of Security Interest is being executed by Congress with the intention that it be recorded in the U.S. Patent and Trademark Office and other offices to evidence that neither Merit Industries nor the Collateral is

subject to the Security Interest set forth in said Security Agreement.


