This RELEASE is given as of this 10<sup>th</sup> day of November 1998 by Citibank, N.A., a national banking association ("Assignor"), located at 339 Park Avenue, New York, New York 10043, in favor of Chargers Football Company, a California limited partnership ("Assignee"), located at 4020 Murphy Canyon Road, San Diego, California.




