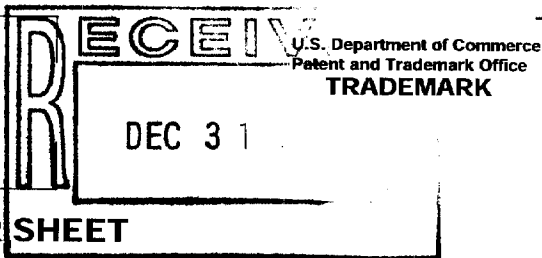

The undersigned, being the sole shareholder of General Cable IP Corporation (the "Corporation"), does hereby unanimously consent and agree pursuant to Section 228 of the Delaware General Corporation Law to the adoption of the following preambles and resolutions, as if duly adopted at a meeting of the shareholders of the Corporation.

WHEREAS, the Board of Directors and the sole shareholder have determined that it is in the best interests of the Corporation to change the name of the Corporation to "General Cable Technologies Corporation."

NOW THEREFORE BE IT RESOLVED THAT:

1. The amendment to the Certificate of Incorporation of the Corporation proposed by the Board of Directors is hereby approved and adopted as follows. The first paragraph of the Certificate of Incorporation of General Cable IP Corporation shall be deleted in its entirety and replaced with the following:


"FIRST: The name of the corporation is General Cable Technologies Corporation."

2. 
