TRADEMARK ASSIGNMENT

AGREEMENT made effective as of the 6th day of August, 1991, by and between SALTON/MAXIM HOUSEWARES GROUP, an Illinois general partnership consisting of Salton Housewares, Inc. (an Illinois corporation) and Financo/Maxim, Inc. (a New Jersey corporation) doing business at 550 Business Center Drive, Mt. Prospect, IL 60056 (hereinafter "ASSIGNOR"); and SALTON/MAXIM HOUSEWARES, INC., a corporation of the State of Delaware doing business at 550 Business Center Drive, Mt. Prospect, IL 60056 (hereinafter "ASSIGNEE").

WHEREAS, ASSIGNOR is the owner by assignment of the entire right, title and interest in and to the U.S. Trademark Registrations and Trademark Applications (collectively, "the Registrations") as set forth on Exhibit B hereto and the trademarks set forth therein (collectively, "the Marks"); and

WHEREAS, ASSIGNOR represents that it has made no prior agreements, licenses, assignments, nor taken any actions which interfere with ASSIGNOR's sole and exclusive rights in and to the Registrations and the Marks; and

WHEREAS, ASSIGNOR wishes to assign and ASSIGNEE wishes to receive and accept the entire right, title and interest in and to the Registrations and the Marks together with the goodwill of the business appurtenant thereto and any and all rights pertaining thereto in foreign countries;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the parties hereto hereby agree as follows:

1. ASSIGNOR hereby assigns to ASSIGNEE ASSIGNOR's entire right, title and interest in and to the Registrations, together with the goodwill of the business appurtenant thereto and any and all rights pertaining thereto in foreign countries, including the right to sue for all past infringements thereof.

The foregoing shall be held and enjoyed by ASSIGNEE for its own use and enjoyment, and for the use and enjoyment of its successors and assigns or other legal representatives, to the end of the term or terms for which said Registrations and Marks are or may be granted, reissued or renewed as fully and entirely as the same would have been held

2. ASSIGNOR agrees, upon the request of ASSIGNEE, to execute any necessary and proper oaths or affidavits relating to the Registrations and the Marks as required for the filing or prosecution of any issuance or renewals thereof which in the opinion of counsel for ASSIGNEE, may deem necessary or expedient.
