**RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, BioStar, Inc., a Delaware corporation, located at 6655 Lookout Road, Boulder, Colorado 80301 ("Debtor"), and Thermo BioAnalysis Corporation, a Delaware corporation, located at 81 Wyman Street, Waltham, Massachusetts 02254 ("Secured Party"), entered into Loan and Security Agreement ("Agreement") and a Grant of Security Interest (Trademarks) (the "Grant"), both dated as of August 31, 1998, that by their terms granted the Secured Party a security interest in certain intellectual property listed in Schedule 1, all pending and registered trademarks, acquired or arising after the date of the Agreement or the Grant (collectively, the "Trademarks"). The Grant was recorded in the United States Patent and Trademark Office on September 4, 1998 at Reel 1788 and Frame 0684.

WHEREAS, the Agreement and the Grant provide that the Secured Party shall execute and deliver to the Debtor a termination of all security interests granted by the Debtor upon the payment and full performance of all obligations incurred under the Agreement and the Grant; and

WHEREAS, Debtor has or has caused to be paid and satisfied in full the obligations for which the security interest in the Trademarks was granted.

NOW THEREFORE the Secured Party hereby releases its security interest in the Trademarks and reassigns to the Debtor any interest in the Trademarks acquired by Secured Party under the Agreement and/or the Grant.

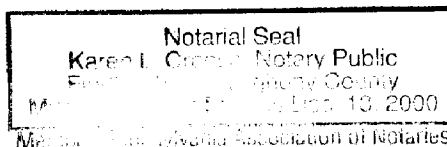
