Pursuant to the provisions of Section 264 of the Delaware General Corporation Law and Section 18-209 of the Delaware Limited Liability Company Act, the undersigned domestic corporation and domestic limited liability company adopt the following Certificate of Merger for the purpose of merging them into one domestic corporation. It is hereby certified as follows:

First: The entities which are to merge (the "Constituent Entities") are:

Agfa Corporation

Fourth: No amendments or changes in the certificate of incorporation of the Surviving Corporation are to be effected by the Merger. The certificate of incorporation of the Surviving Corporation, as now in force and effect, shall continue to be the certificate of incorporation of the Surviving Corporation until amended in accordance with the laws of the State of Delaware.




Fifth: The effective date and time of this Certificate shall be 12:03 a.m., Eastern Standard Time, on January 1, 1999.

Sixth: The executed Merger Agreement is on file at the principal place of business of the Surviving Corporation, which is currently located at 100 Challenger Road, Ridgefield Park, New Jersey 07660-2500.

Sarafian, Assistant Secretary of Agfa Corporation, a Delaware corporation, hereby certify that the following is a true and complete copy of sections of the Contribution and Assumption Agreement dated as of December 15, 1998 by which Bayer Corporation contributed to the capital of RFP, LLC, a Delaware limited liability company, all of the assets and liabilities that Bayer deems to be attributable to or associated with the business conducted by the Agfa Division of Bayer Corporation:

Effective as of each Interim Closing Date, Bayer shall, and hereby does, transfer, assign, convey and deliver to RFP, and RFP shall, and hereby does, acquire from Bayer, all of the right, title and interest of Bayer, immediately prior to the applicable Interim Closing, in and to the Contributed Assets ... The term "Contributed Assets" means all property and assets, real, personal or mixed, tangible and intangible, of every kind and description, wherever located, that are deemed by Bayer to be attributable or related to, or associated with, the Business, including, without limitation (i) all goodwill associated with the Business, and (ii) the following (but not excluding any Excluded Assets): ...

(f) All of the right, title and interest of Bayer in and to (i) the inventions, discoveries, improvements, processes, methods, knowhow, information technology, other technology, patents (including utility patents, design patents, industrial designs and utility models) and applications therefor, copyrights, trademarks, all goodwill associated with such trademarks, trade dress, commercial symbols, logos, trade names, service marks and service names, whether or not recorded or registered or arising under common law, registrations and recordations thereof, whether domestic (federal or state) or foreign, and applications for the registration or recordation thereof, and other intangible property rights of, pertaining to or associated with the Business (collectively, "Intellectual Property"), including, without limitation, the Intellectual Property listed on Schedule 2.02(f) hereto, and (ii) license, research and development, knowhow and other agreements granting to Bayer the right to use or employ Intellectual Property (collectively, "Intellectual Property Agreements"), including, without limitation, the Intellectual Property listed on Schedule 2.02(f) hereto, whether or not included on the Balance Sheet, but specifically not including all Intellectual Property and all Intellectual Property Agreements listed as Excluded Assets on Schedule 2.03 hereto, if any; provided, however, that Bayer shall have no obligation to effect the reregistration in the name of RFP (or Agfa Corporation, as the successor to RFP as a result of the Merger) of any patent currently registered in the name of a predecessor to Bayer (but Bayer shall, after the Final Closing Time, provide reasonable assistance to RFP or Agfa Corporation in effecting any such patent reregistration that RFP or Agfa Corporation, as the case may be, determines to be necessary or desirable for the Business, but RFP or Agfa Corporation, as the case may be, shall reimburse Bayer for all costs and expenses incurred by Bayer in effecting any such patent reregistration);



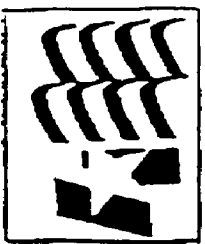
