All rights of London Pacific Life & Annuity Company ("LPL&AC") under that certain Senior Secured Loan Agreement dated as of April 30, 1993 (as amended, the "Loan Agreement") between OCEAN PACIFIC APPAREL CORP. (formerly known as Ocean Acquisition Corp.), a Delaware corporation ("Ocean Pacific") and Berkeley Atlantic Income Limited ("BAIL"), as amended pursuant to that certain Waiver and Amendment dated as of December 31, 1993 between Ocean Pacific and BAIL, and pursuant to that certain Second Amendment to Loan Agreement dated as of July 12, 1994 between Ocean Pacific and BAIL, and as assigned and transferred to BG Services Limited ("BGSL") pursuant to a Transfer Agreement dated as of May 24, 1996 between BAIL and BGSL and as subsequently assigned and transferred by BGSL to LPL&AC pursuant to a Transfer Agreement dated as of June 28, 1996 between BGSL and LPL&AC, and as further amended pursuant to a Waiver and Third Amendment to Loan Agreement dated as of April 23, 1997 between Ocean Pacific and LPL&AC.

That certain Senior Secured Promissory Note issued by Ocean Pacific to BAIL pursuant to the Loan Agreement, dated as of April 30, 1993 in the original principal amount of \$8,000,000, of which \$4,000,000 has been prepaid by Ocean Pacific (leaving a current principal balance of \$4,000,000), as such Note has been amended and assigned to BGSL and then to LPL&AC as described above.




