#### NOTICE OF COLLATERAL ASSIGNMENT OF TRADEMARKS

1. Pursuant to the Security Agreement, as supplemented by this Notice, the Grantor has assigned to the Agent for collateral purposes and has granted to the Agent a security interest in, among other things, all of the following (collectively, the "Trademark Collateral"): all trademarks, trademark registrations, service marks, service mark registrations, tradenames, trademark and service mark applications (a) all renewals thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, (d) all rights corresponding thereto throughout the world, (e) all of the goodwill of Grantor's business connected with and symbolized by the trademarks, service marks, tradenames or other items described in clauses (a)-
