THIS ASSIGNMENT is made the 26TH day of September 1997

BETWEEN

- (1) UK PAPER PLC, a company incorporated in England and Wales under the Companies Acts (registered number 2010490) and having its principal office at Sittingbourne, Kent ME10 3ET (hereinafter referred to as "the Assignor") and
- (2) DONSIDE PAPERS LIMITED, a company incorporated in Scotland under the Companies Acts (registered number 177775) and having its registered office at 11 Walker Street, Edinburgh EH3 7NE (hereinafter referred to as "the Assignee")



WHEREAS:

- (A) The Assignor is the registered proprietor of the registered trade marks as set out in the Schedule hereto (the "Trade Marks").
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee.

NOW THEREFORE THIS AGREEMENT WITNESSES THAT:

- (1) In consideration of the sum of £1 sterling (receipt of which is hereby acknowledged) the Assignor as beneficial owner hereby assigns to the Assignee the entire right, title and interest of the Assignor in and to the Trade Marks and in and to the registrations thereof including all common law rights connected therewith and its right of action, belonging or accrued arising therefrom and its right to take proceedings to recover damages and claim all other relief in respect of any act of infringement thereof or any acts actionable in passing off at common law whether such act shall have been committed before or after the date of this Assignment, TOGETHER WITH the goodwill relating to the Trade Marks in the country indicated for such Trade

Mark in the Schedule TO HOLD the same unto the Assignee and its assigns absolutely.

- (2) The Assignor and Assignee hereby agree that the change of ownership be recorded in the official Trade Marks Register in the relevant country at the cost of the Assignee.
- (3) At the request of the Assignee, the Assignor hereby undertakes to take all actions and to execute all such further documents, forms and authorisations as may be required by any registrar of trade marks (or equivalent) or which may otherwise be necessary for absolutely vesting the rights hereby assigned in the Assignee.
- (4) This Agreement shall be governed by and construed in accordance with English law and the parties hereby prorogate the non-exclusive jurisdiction of the English courts.

AS WITNESS the parties have executed this Deed on the day and year first above written.




