

U.S. AND FOREIGN TRADEMARK ASSIGNMENT

THIS ASSIGNMENT AND ASSUMPTION is effective this 30th day of June, 1998 ("Effective Date"), from CCPC Holding Company, Inc., a Delaware corporation formerly known as Corning Consumer Products Company ("Assignor"), to Corning Consumer Products Company, a Delaware corporation formerly known as Revere Ware Corporation ("Assignee").

WHEREAS, Assignor owns certain trademarks, service marks and related rights, as hereinafter defined; and

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee, its successors and assigns forever, Assignor's entire right, title and interest in, to and under the following:

1. Any and all trademarks and service marks, trade names, corporate names, logos, rights referred to as "trade dress," and other words, designations, labels, symbols, designs, colors, color combinations, product configurations and indicia used or intended to be used in connection with the business, including any and all United States, state or foreign registrations issued, applications filed, or common-law rights related to any of the foregoing, including without limitation those trademark registrations listed on Schedule A annexed hereto, together with the goodwill of Assignor's business appertaining thereto ("Trademarks"), provided, however, Trademarks shall not include any rights in the trademarks CORNING, CORNING WARE, CORNINGWARE, PYROCERAM, or PYREX as such are covered by license agreements between Corning Incorporated and Assignor;
2. Any and all other rights and privileges provided under United States, state or foreign law with respect to the foregoing, including without limitation the laws of unfair competition; and any and all rights in, to and under any and all licenses and other agreements and documents relating to any of the foregoing ("Related Rights");
3. Any and all rights to sue at law or in equity for any infringement, imitation, impairment, distortion, dilution or other unauthorized use or conduct in derogation of the Trademarks and Related Rights occurring prior to the execution of this Assignment, including the right to receive all proceeds and damages therefrom; and

4. Any and all rights to obtain renewals or other legal protections pertaining to the Trademarks and Related Rights.

Assignee, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Trademarks and Related Rights, and all renewals thereof, as fully and as entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor shall, without further consideration, comply with a request by Assignee to execute promptly any additional documents and to take promptly any further action necessary to protect, secure and vest good, valid and marketable title to the Trademarks and Related Rights in Assignee and to record this Assignment with all appropriate authorities.

IN WITNESS WHEREOF, the undersigned has caused this Assignment to be duly executed and delivered as of the 30th day of June, 1998.
