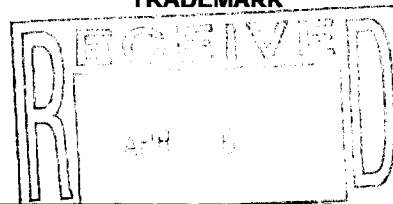

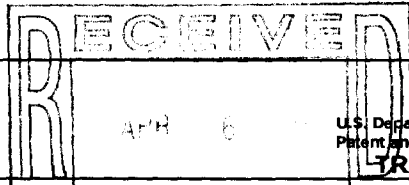

NUNC PRO TUNC ASSIGNMENT OF
UNITED STATES TRADEMARK REGISTRATIONS

WHEREAS, TANDEM COMPUTERS INCORPORATED, a Delaware corporation, having a place of business located at 19191 Vallco Parkway, Cupertino, California 95014-2599, hereinafter "TCI," has adopted and used trademarks which are registered or are the subject of pending applications for registration in the United States Patent and Trademark Office, as set forth on annexed Schedule A, as well as all other trademarks and trademark registrations owned by TCI throughout the world, hereinafter referred to as "the Trademarks";

WHEREAS, effective December 30, 1998, COMPAQ INFORMATION TECHNOLOGIES GROUP, L.P., a Texas limited partnership having a place of business at 20555 State Highway 249, Houston, Texas 77070, the general partner of which is CPQ HOLDINGS, INC., a Delaware corporation, and a limited partner of which is COMPAQ INFORMATION TECHNOLOGIES, INC., a California corporation, the partnership being referred to hereinafter as "CITG," did acquire all right, title and interest in and to the Trademarks, including any choses in action relating to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the registrations and applications thereof;

WHEREAS, it is desired that this Nunc Pro Tunc Assignment of the Trademarks be made a matter of record in the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, TCI does hereby sell, assign, transfer and convey unto CITG *nunc pro tunc* as of December 30, 1998, all of its right, title and interest in and to the Trademarks, including any choses in action relating to the Trademarks, claims for damages, profits and costs, both in equity and law, for any infringement or

infringements of said Trademark rights accruing on or before December 30, 1998, together with the goodwill of the business symbolized by the Trademarks, and including the registration thereof as set forth above; and further, TCI hereby covenants, agrees and undertakes to execute, whenever requested by CITG, all applications, assignments, lawful oaths and any other papers which CITG may deem necessary or desirable for securing to CITG or for maintaining for CITG the Trademarks which were assigned, and the choses in action therefor, all without further compensation to TCI.

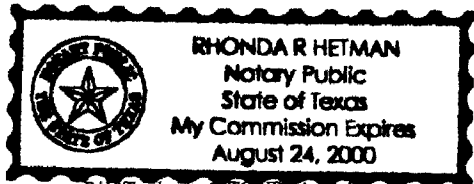
