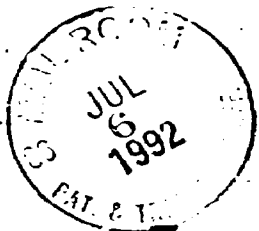

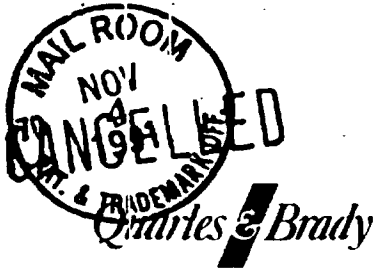

ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, the Assignor hereby sells, assigns and transfers to the Assignee, its successors and assigns, the entire right, registrations thereof, as described in Schedule A attached hereto, and in and to the goodwill of the business in connection with which said trademarks are used, and all rights and privileges pertaining to said trademarks, including the right to sue and recover for past infringements thereof.
