**WESTWOOD STUDIOS, INC.  
ASSIGNMENT AGREEMENT**

This Agreement is entered into as of November 12, 1998 (the "*Effective Date*") by and between Westwood Studios, Inc., a Nevada corporation with its principal business offices at 2400 North Tenaya Way, Las Vegas, Nevada 89128 ("*Westwood*") and Electronic Arts Inc., a Delaware corporation with its principal business offices at 209 Redwood Shores Parkway, Redwood City, CA 94065 ("*EA*").

**RECITALS**

- A. Westwood is a wholly-owned subsidiary of EA.
- B. Westwood and EA, as Westwood's sole shareholder, have determined that it is in the best interests of both companies that Westwood's intellectual property assets be assigned to EA.

Now, therefore, the parties agree as follows:

**1. ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS**

For good and valuable consideration, receipt of which is hereby acknowledged, Westwood hereby assigns to EA all of Westwood's right, title and interest, of whatever kind and nature forever and throughout the universe, in and to any and all of Westwood's intellectual property assets and rights (including but not limited to, copyrights, moral rights, patents, patent applications, trademarks, service marks, trade names and trade secrets, and specifically including those trademark registrations and applications listed on Exhibit A attached hereto, and those copyright registrations and applications listed on Exhibit B attached hereto) all rights to receive any of the foregoing, and all proceeds thereof (the "*Westwood IP Assets*"). The Westwood IP Assets shall also be deemed to include the results and proceeds of the services of all persons rendering services in connection with the interactive products, the rights of which are being assigned hereunder.

**2. FURTHER DOCUMENTS**

Westwood agrees to execute and deliver to EA such further instruments as may be reasonably required to carry out or effectuate the purposes and intent of this Assignment. Without limiting the foregoing, Westwood hereby agrees to cause to be executed, acknowledged and delivered to EA, upon EA's request (a) a short form assignment in a form to be prepared by EA, which such instrument EA may record with the United States Copyright Office, and any other applicable copyright registries, as evidence of the rights granted to EA herein; and (b) a short form assignment in a form to be prepared by EA, which such instrument EA may record with the United States Patent and Trademark Office, and any other applicable trademark registries, as evidence of the rights granted to EA herein.

**3. ASSUMPTION OF OBLIGATIONS**

EA hereby agrees to assume all of Westwood's current and future obligations and liabilities related to the Westwood IP Assets, whether certain or contingent, including but not limited to all liabilities for taxes, liabilities under contracts, liabilities for any tort, malfeasance or omission committed by Westwood (or any of Westwood's officers or directors in the course of their duties for Westwood), and other liabilities imposed by law, whether arising prior to the Effective Date or thereafter.
