The undersigned, Harry Drum, the President, and Rick Wasserman, the Secretary, of PapeL Freelance, Inc., a New Jersey corporation (the "Corporation"), hereby certify that:

1. The Corporation was incorporated under the name "PF Acquisition Corp." and the Certificate of Incorporation of the Corporation was filed with the Secretary of State of New Jersey on October 20, 1995. The name of the Corporation was changed to PapeL Freelance, Inc. pursuant to the Certificate of Amendment filed with the Secretary of State of New Jersey on February 2, 1996.

2. The first sentence of Article FIRST of the Certificate of Incorporation is hereby deleted and replaced by the following:

"The name of the Corporation is:  
PapeL Giftware, Inc."

3. The above amendment to Article FIRST of the Certificate of Incorporation was duly adopted by the directors of the Corporation by written consent dated as of February 13, 1998 pursuant to Section 14A:6-7.1 of the New Jersey Business Corporation Act.

The above amendment to Article FIRST of the Certificate of Incorporation was duly adopted by the sole stockholder of the Corporation by written consent dated as of February 13, 1998, pursuant to Section 14A: 5-6 of the New Jersey Business Corporation Act. At the time the amendment was adopted, one hundred (100) shares of common stock, no par value per share, were outstanding and entitled to vote on the above amendment and all one hundred (100) shares voted for said adoption and none of the shares voted against said adoption.

5. The above amendment to Article FIRST of the Certificate of Incorporation was duly adopted in accordance with the applicable provisions of Section 14A:9-2 of the New Jersey
