## AGREEMENT OF ASSIGNMENT

This AGREEMENT OF ASSIGNMENT is dated June 30, 1998 and is by and between:

THOMSON NEWSPAPERS INC. (hereinafter "TNI"), a corporation organized and existing under the laws of the State of Delaware, having its principal office at 208 Harbor Drive, Stamford, Connecticut 06902; and

THOMSON NEWSPAPERS LICENSING CORPORATION (hereinafter "TNLC"), a corporation organized and existing under the laws of the State of Delaware, having its principal office at Two Mill Road, Wilmington, Delaware 19806.

WHEREAS, TNI has used and/or is using in its business certain marks consisting of the words shown on Schedule "A" attached hereto, which words are used alone and in combination with other words and/or in combination with various designs; and

WHEREAS, TNLC is desirous of acquiring all of the right, title and interest which TNI has acquired and has developed in said marks throughout the world;

NOW, THEREFORE, for good and valuable consideration, as hereinafter set forth, the parties agree as follows:

### 1. <u>Definition</u>:

The "Trademarks" mean the marks shown in Schedule A hereto, as well as all other marks which have heretofore been used by TNI as trademarks, service marks or trade names by virtue of their use on or in connection with the products or services of TNI.

2. <u>Assignment of Trademarks</u>:

TNI assigns to TNLC:

(a) the Trademarks;

(b) all issued trademark registrations for the Trademarks and all pending applications

to register the Trademarks in the United States and throughout the world, and all trademark

registrations deriving from said applications if any;

(c) all of the goodwill of the business symbolized by the Trademarks; and

(d) all claims and proceeds relating to the foregoing including, without limitation, any

claims by TNI against third parties for past infringement of the Trademarks or injury to the

goodwill of the business symbolized by the Trademarks.

3. Consideration:

In consideration of the assignment and other transfers contained herein, TNLC shall,

upon execution of all required documents by TNI, transfer to TNI all of the outstanding shares of

TNLC common stock equal in value to the book value of the trademarks as of June 30, 1998.

4. Representations and Warranties of TNI:

TNI represents and warrants to TNLC as follows:

(a) <u>Title to Trademarks</u>. TNI owns beneficially and of record, free and clear of any

lien or other encumbrance, the Trademarks and, upon execution of this Agreement of

Assignment, TNLC will acquire good, valid and marketable beneficial ownership of the

Trademarks, free and clear of any lien or other encumbrance of any kind.

(b) Authority to Execute and Perform Agreement. TNLC has the full legal right and

power and all authority and approvals required to enter into, execute and deliver this Agreement

and to perform fully TNI's obligations hereunder, and this Agreement, upon execution and delivery by TNI, will be duly executed and delivered by TNI and (assuming due execution and delivery by TNLC) will be the valid and binding obligation of TNI enforceable against TNI in accordance with its terms.

- (c) No Infringement or Claims. To TNI's knowledge, the rights of TNI in the Trademarks do not infringe the rights of others and are not being infringed by others, and TNI has no notice of any adversely held trademark, service mark or trade name of any other person or notice of any claim of any other person relating to the Trademarks and does not know of any basis for any such claim.
- 5. Representations and Warranties of TNLC:

TNLC represents and warrants to TNI as follows:

- (a) Authority to Execute and Perform Agreement. TNLC has the full legal right and power and all authority and approvals required to enter into, execute and deliver this Agreement and to perform fully its obligations hereunder. This Agreement, upon execution and delivery by TNLC, will be duly executed and delivered by TNLC and (assuming due execution and delivery by TNI) will be the valid and binding obligation of TNLC enforceable against TNLC in accordance with its terms.
- 6. Registration and Further Assurances:

TNI, at TNLC's reasonable expense, shall execute all instruments and do all acts and otherwise use its best efforts to effectuate the purpose of this Agreement and to procure the acceptance of all applications for and registrations of the Trademarks and the registration of

TNLC as the registered owner thereof. TNLC shall compensate TNI for its out of pocket expenses incurred in the performance of this paragraph.

#### Governing Law: 7.

This Agreement shall be governed and construed in accordance with the laws of the State of Delaware applicable to agreements made and to be performed entirely within such State.
