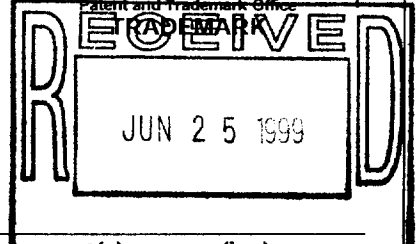

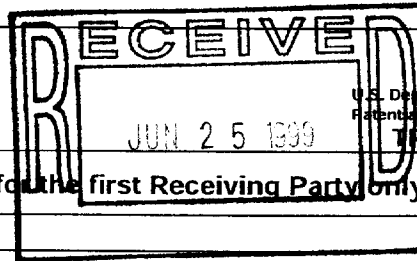

RELEASE, DISCHARGE AND TRADEMARK ASSIGNMENT

Whereas, Bird Incorporated, a Massachusetts corporation having a place of business at 980 Washington Street, Suite 120, Dedham, Massachusetts 02026-6714, pursuant to a certain Trademark Collateral Assignment and Security Agreement (the "Agreement"), dated as of November 30, 1994, granted a security interest and first priority lien in and granted, assigned, transferred and conveyed a conditional assignment in the Trademark Collateral as that term is defined in said Agreement, including the trademarks and the United States trademark registrations and applications set forth in Schedule A hereto, to Barclay's Business Credit, Inc., a Connecticut Corporation having a place of business at 200 Glastonbury Boulevard, Glastonbury, Connecticut 06033;

Whereas, Barclay's Business Credit, Inc. assigned to Shawmut Capital Corporation, a Connecticut corporation having a place of business at 200 Glastonbury, Connecticut 06033, its entire interest in and to the Agreement, including the security interest and first priority lien and the conditional assignment in the Trademark Collateral conveyed by the Agreement; and

Whereas, Bird Incorporated has partially discharged its obligations under the Agreement.

Now, Therefore:

Shawmut Capital Corporation hereby releases and discharges any and all security interests originally conveyed to, and subsequently assigned to it by, Barclay's Business Credit Corporation in and to the Trademark Collateral, to the extent of the trademarks and the United States trademark registrations and applications for registration thereof set forth in the attached Schedule A and other Trademark Collateral related thereto and grants, assigns, transfers, and conveys to Bird Incorporated the entire right, title and interest in and to the trademarks and the United States trademark registrations and applications thereof together with all goodwill associated therewith, set forth in the attached Schedule A, previously conditionally assigned, as set forth above, to Barclay's Business Credit, Inc., and assigned by Barclay's Business Credit, Inc. to Shawmut Capital Corporation.
