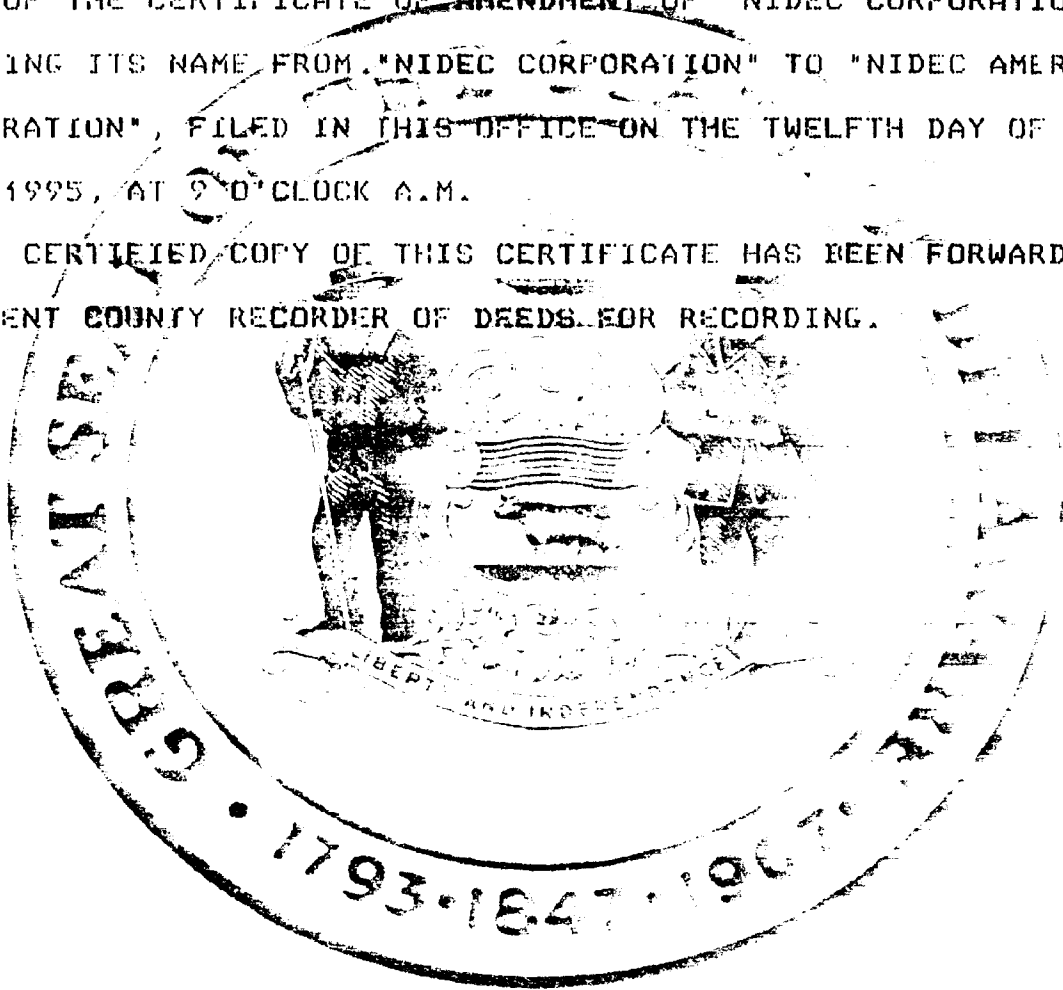

Nidec Corporation, a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), hereby certifies as follows:

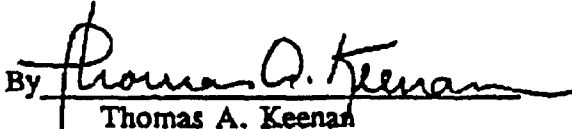
FIRST: That the first article of the Certificate of Incorporation of the Corporation be amended to read as follows:

FIRST: Name. The name of the corporation is Nidec America Corporation (the "Corporation").

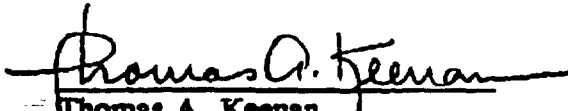
