

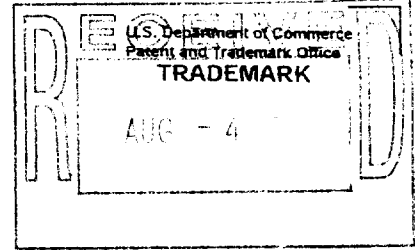





It is hereby certified that:

1. BERWIND INDUSTRIES, INC. [hereinafter sometimes referred to as the "Corporation"] is a business corporation of the State of Delaware.
2. The Corporation is the owner of all of the outstanding shares of the stock of BINDICATOR COMPANY, which is also a business corporation of the State of Delaware.
3. On September 11, 1997, the Board of Directors of the Corporation adopted the following resolutions to merge BINDICATOR COMPANY into the Corporation:

RESOLVED, that the Plan of Merger (attached as Exhibit A), merging BINDICATOR COMPANY, a Delaware corporation, with and into this Corporation, to be effective as of the close of business on September 18, 1997 is hereby approved; and

FURTHER RESOLVED, that upon consummation of the merger pursuant to the Plan of Merger, this Corporation, as the surviving corporation, assume all the obligations and liabilities of BINDICATOR COMPANY; and

FURTHER RESOLVED, that each of the President and any Vice President of this Corporation is directed to make and execute a Certificate of Ownership and Merger merging BINDICATOR COMPANY into this Corporation, and to cause the same to be filed with the Secretary of State and a certified copy recorded in the office of the Recorder of Deeds of New Castle County and to do all acts and things whatsoever whether within or without the State of Delaware, which may be necessary or proper to effect said merger; and

FURTHER RESOLVED that each of the President and any Vice President of this Corporation is hereby authorized and directed to take whatever action and to execute and deliver such documents and instruments as he or she may deem to be necessary or desirable to consummate and carry out the foregoing resolutions.

1. BERWIND INDUSTRIES, INC., which is a business corporation of the State of Delaware and is the parent corporation and the owner of all of the outstanding shares of BINDICATOR COMPANY which is a business corporation of the State of Delaware and the subsidiary corporation, hereby merges BINDICATOR COMPANY into BERWIND INDUSTRIES, INC. pursuant to the provisions of the Delaware General Corporation Law .
2. The separate existence of BINDICATOR COMPANY shall cease at the effective time and date of the merger pursuant to the provisions of the Delaware General Corporation Law and BERWIND INDUSTRIES, INC. shall continue its existence as the surviving corporation pursuant to the provisions of the Delaware General Corporation Law.


