TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS ("Release"), dated as of August 13, 1999, by BANKBOSTON, N.A., f/k/a THE FIRST NATIONAL BANK OF BOSTON, a national banking association, as Agent for itself and the other lenders (the "Banks") party to the Second Amended and Restated Revolving Credit Agreement, dated as of April 25, 1997, among Republic Engineered Steels, Inc. (the "Company") the Agent and the Banks.

WHEREAS, pursuant to the terms of a TRADEMARK COLLATERAL ASSIGNMENT AGREEMENT, dated as of November 28, 1989, (the "Trademark Agreement"), as amended, by and between the Company and the Agent, the Company granted to the Agent, for the benefit of the Agent and the Banks, a security interest in and lien on, and collaterally assigned to the Agent, for the benefit of the Agent and the Banks, all of its trademarks, service marks, trademark and service mark registrations, and trademark and service mark registration applications listed on Schedule A attached hereto (the "Trademark Collateral").

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office on or about December 1, 1989 at Reel 0679, Frame 0752, amended by the First Amendment to Trademark collateral Assignment Agreement dated as of December 21, 1993, which was recorded with the PTO on or about December 27, 1993 at Reel 1081, Frame 0257, amended by the Second Amendment to Trademark Collateral Assignment Agreement dated as of April 25, 1997, which was recorded with the PTO on or about August 18, 1997 at Reel 1643, Frame 0524.

WHEREAS, the Agent has agreed to terminate and release its security interest and all of its right, title and interest in the Trademark Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank and the Company hereby agree as follows:

- 1. Release and Assignment. The Agent hereby terminates and releases its security interest in and lien on, and assigns to the Company all of the Agent's right, title and interest in and to the Trademark Collateral and the related trademark registrations and goodwill, effective as of the date set forth above.
- 2. Acknowledgment and Acceptance. The Company hereby acknowledges and accepts the foregoing release and assignment by the Agent.
- 3. <u>Counterparts</u>. This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
