### RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") made as of the **17** day of November, 1999 by CANADIAN IMPERIAL BANK OF COMMERCE, as Coordinating and Collateral Agent, with an office at 425 Lexington Avenue, New York, NY 10017.

The Agent will execute and deliver to the Grantor, in a commercially reasonable manner, at the Grantor's expense, such additional documents as may be
