## TRADEMARKS ASSIGNMENT

WHEREAS, RPC Corporation, d/b/a ROPCO, a corporation organized and existing under the laws of the State of North Carolina and having a place of business at Highway 501 South, Roxboro, North Carolina, United States of America, is the record owner of and has adopted and used in its business the following registered United States trademarks:

WHEREAS an Involuntary petition for Relief under Chapter 7 of the United States Bankruptcy Laws was filed by creditors of RPC Corporation on July 24, 1986 in the United States Bankruptcy Court, Middle District of North Carolina, Case No. B-86-01472C-7.

WHEREAS, on July 29, 1986, after notice to all creditors and interested parties, a hearing was held and an order entered in open court and signed subsequently thereafter on August 26, 1986, William L. Yaeger was appointed by Hon. James B. Wolfe, Jr., United States Bankruptcy Judge, as Trustee of the estate of the Debtor, RPC Corporation, a certified copy of the order being attached hereto as Exhibit A.

WHEREAS, the Order of July 29, 1986 authorized said William L. Yaeger, Trustee to execute any and all documents necessary or appropriate to effectuate the sale of certain assets on behalf of the estate of RPC Corporation to Bromma, Inc., a Swedish corporation having a place of business at P. O. Box 659, New Milford, Connecticut.

WHEREAS, on July 30, 1986 by order of the Bankruptcy Court, certain assets of RPC Corporation were sold at public auction in Roxboro, North Carolina to Bromme, Inc. including the aforementioned U. S. trademark registrations and all trademark rights relating thereto.

NOW, THEREFORE, To All Whom It May Concern:

Be it known that for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration to him in hand paid, the receipt of which is hereby acknowledged, I, William L. Yaeger, Trustee of the estate of RPC Corporation, by these presents do hereby sell, assign, and transfer unto the said Bromme, Inc., its successors and assigns, the entire right, title and interest in and to the aforesaid United States Trademark Registrations together with the good will and assets of the business in connection with which the said trademarks are used.
