PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

THIS PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Agreement"), dated as of October 28, 1999, is made by MALDEN MILLS INDUSTRIES, INC., a Massachusetts corporation ("Borrower"), INDEPENDENT FURNITURE SUPPLY CO., INC., a Massachusetts corporation ("IFS"), ADS PROPERTIES CORP., a Vermont corporation ("ADS"), AES PROPERTIES CORP., a Vermont corporation ("AES"), MALDEN MILLS DISTRIBUTORS CORP., a Massachusetts corporation ("Malden Distributors"), MALDEN MILLS FSC, INC., a Virgin Islands corporation ("FSC"), MALDEN MILLS OF CANADA LIMITED, a Canadian corporation ("Malden Canada"), and MALDEN MILLS GMBH, a German limited liability company ("Malden GmbH") (Borrower, IFS, ADS, AES, Malden Distributors, FSC, Malden Canada, and Malden GmbH being referred to collectively as "Grantors" and each individually as a "Grantor"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION, a New York corporation, as agent (in such capacity, "Agent") for the lenders ("Lenders") from time to time parties to the Term Loan Agreement (as defined below).

RECITALS

A. Pursuant to that certain Credit Agreement of even date herewith by and among Grantors, the other credit parties party thereto, the lenders from time to time signatory thereto (the "Senior Lenders"), and General Electric Capital Corporation, as agent (in such capacity, "Senior Agent") for the Senior Lenders (including all annexes, exhibits and schedules thereto, and as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), Senior Agent and Senior Lenders have agreed to extend certain financial accommodations to or for the direct or indirect benefit of Grantors. The obligations of Grantors under the Credit Agreement and the other Loan Documents as defined therein (the "Senior Loan Documents") are secured by senior security interests in substantially all of the tangible and intangible assets of Grantors.

B. Pursuant to that certain Term Loan Agreement of even date herewith by and among Grantors, the other credit parties party thereto, Lenders and Agent (including all annexes, exhibits and schedules thereto, and as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Term Loan Agreement"), Lenders have agreed to make Term Loan C (as defined in the Term Loan Agreement) to or for the direct or indirect benefit of Grantors.

C. In order to induce Agent and Lenders to enter into the Term Loan Agreement and the other SCIL Documents (as defined in the Term Loan Agreement) and to induce Lenders to make Term Loan C as provided for in the Term Loan Agreement, Grantors have agreed to execute and deliver to Agent, for the benefit of Agent and Lenders, that certain Security Agreement of even date herewith made by Grantors in favor of Agent, for the benefit of Agent and Lenders (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

D. Pursuant to the Security Agreement, Grantors are required to execute and deliver to Agent, for the benefit of Agent and Lenders, this Patent, Trademark and Copyright Security Agreement.

## AGREEMENT

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors and Agent hereby agree as follows:

1. Definitions. Unless otherwise defined herein, capitalized terms or matters of construction defined or established in Annex A to the Term Loan Agreement shall be applied herein as defined or established therein. All other undefined terms contained in this Agreement, unless the context indicates otherwise, shall have the meanings provided for by the Code to the extent the same are used or defined therein.

2. Subordination. The parties hereto hereby acknowledge and agree that (a) the Liens now or hereafter held by Agent, for the benefit of Agent and Lenders, in and to any of the assets or property of any Grantor, including the Intellectual Property Collateral (as defined in Section 3), are and shall be subject and subordinate in priority to the Liens now or hereafter held by Senior Agent, for benefit of Senior Agent and Senior Lenders, in and to any such assets or property, and (b) the rights of Agent and Lenders hereunder are subject and subordinate to the rights of Senior Agent and Senior Lenders under the Credit Agreement and the other Senior Loan Documents pursuant to the subordination provisions set forth in Section 9 of the Term Loan Agreement.

3. Grant of Security Interest in Intellectual Property Collateral. Each Grantor hereby grants to Agent, for the benefit of Agent and Lenders, a continuing Lien upon all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Intellectual Property Collateral");

(a) all of such Grantor's Patents and Patent Licenses to which it is a party, including those referred to in Part A to Schedule I hereto, and all reissues, continuations or extensions thereof;

(b) all of such Grantor's Trademarks and Trademark Licenses to which it is a party, including those referred to in Part B to Schedule I hereto, and all reissues, continuations or extensions thereof;

(c) all of such Grantor's Copyrights and Copyright Licenses to which it is a party, including those referred to in Part C to Schedule I hereto;

(d) all Goodwill, trade secrets, proprietary or confidential information, technical information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles with respect to the foregoing; and

(e) all Proceeds of the foregoing, including (i) any and all proceeds of any insurance, indemnity, warranty or guaranty payable to any Person from time to time with respect to

any of the foregoing, (ii) any and all payments (in any form whatsoever) made or due and payable to any Person from time to time in connection with any requisition, confiscation, condemnation, seizure or forfeiture of all or any part of the foregoing by any Governmental Authority (or any Person acting under color of Governmental Authority), (iii) any claim of any Person against third parties for (A) past, present or future infringement of any Patent or Patent License, (B) past, present or future infringement or dilution of any Copyright, Copyright License, Trademark, or Trademark License, or (C) injury to the Goodwill associated with any License, Patent, Trademark or Copyright, (iv) any recoveries by any Person against third parties with respect to any litigation or dispute concerning any of the foregoing, and (v) any and all other amounts from time to time paid or payable under or in connection with any of the foregoing, upon disposition or otherwise.

4. Security Agreement. The Lien granted pursuant to this Agreement is granted in conjunction with the Liens granted to Agent, for the benefit of Agent and Lenders, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the Liens granted under this Agreement are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

5. Malden GmbH Liability Limitations.

(a) Notwithstanding any provision herein contained to the contrary, the enforcement by Agent of its rights and remedies against Malden GmbH under this Agreement shall, if and to the extent that the Obligations of, and Liens granted by, Malden GmbH hereunder secure Obligations of an affiliated company (*verbundenes Unternehmen*) within the meaning of Section 15 of the German Stock Corporation Act (*Aktiengesetz*) (other than any Subsidiary of Malden GmbH), at all times be limited to the extent that such enforcement and the subsequent application of proceeds resulting therefrom against the Obligations would cause Malden GmbH to not have sufficient assets to maintain its capital (*Stammkapital*); provided, that for purposes of determining the net assets of Malden GmbH the following balance sheet items shall be adjusted as follows:

(i) the amount of any increase of capital (*Stammkapital*) out of retained earnings (*Kapitalerhöhung aus Gesellschaftsmitteln*) after the date hereof that has been effected without the prior written consent of Agent, acting for and on behalf of itself and Lenders, shall be deducted from the capital (*Stammkapital*); and

(ii) loans and other contractual liabilities incurred in negligent or willful violation of the provisions of the Term Loan Agreement shall be disregarded.

(b) The financial liability of Malden GmbH hereunder in respect of the Obligations shall be further limited if without such limitation a material incremental tax liability would be incurred by Malden GmbH or Borrower solely and directly as a result of Malden GmbH's execution and delivery of the SCIL Documents and the transactions contemplated therein. Whether and to what extent such limitation is required shall be determined by one or more qualified independent tax advisors appointed by Agent. Such determination shall be made by any such advisor without regard or giving effect to offsetting deductions or credits that might otherwise be available to reduce the dividend or income, as the case may be, that might otherwise give rise to such incremental tax liability.

6. CHOICE OF LAW. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE FEDERAL LAWS OF THE UNITED STATES OF AMERICA AND THE INTERNAL LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS MADE AND PERFORMED IN THAT STATE (WITHOUT REGARD TO THE CONFLICT OF LAW PROVISIONS THEREOF).
