Such amendment shall also delete this and the following paragraph of this Article FIRST."

"Any amendment of this Article PIRST, except the amendment specifically authorized by the foregoing paragraph, shall require the unanimous vote of the entire Board of Managers of the Company and the unanimous vote of all members of the Company."

THED: That the amendment was duly adopted in accordance with the provisions of section 18-202 of the Limited Liability Company Act of the State of Delaware.
