## ASSIGNMENT OF TRADEMARKS

This Assignment dated as of June 2, 1999 is entered into by and between FUTORIAN FURNISHINGS, INC., a Delaware corporation ("Assignor") and STRATFORD UPHOLSTERY COMPANY, L.L.C., a Delaware limited liability company ("Assignee").

### PRELIMINARY STATEMENT

Assignor and Assignee are parties to the Asset Purchase Agreement dated May 28, 1999 (the "Agreement"), pursuant to which Assignor agreed to sell and assign to Assignee certain Intellectual Property assets of Seller, including certain trademarks and to assign to Assignee its right, title and interest therein and all licenses therefor, together with all goodwill therein or associated therewith.

NOW, THEREFORE, in consideration of mutual promises herein contained in the respective representations, warranties, covenants and agreements enumerated in the Agreement, and intending to be legally bound, the parties hereto agree as follows:

1. **Definitions.** Capitalized terms used herein and not otherwise defined herein shall have the meaning ascribed in the Agreement.
2. **Assignment.** Assignor hereby assigns to Assignee all its right, title and interest in the trademarks described on the attached Schedule A ("Trademarks"), together with all goodwill therein or associated therewith. The present assignment includes all rights and interests associated with the Trademarks, including, without limitation, Assignor's common law rights and federal registration rights in the trademarks identified in Schedule A, the right to sue for past trademark infringement and the right to claim prior use of the Trademarks by Assignor as a basis for federal and/or state trademark registration or in connection with any infringement proceeding or claim of a third party with respect to any or all of the Trademarks. In addition, any continued use by Assignor of the Trademarks shall inure to the benefit of Assignee.
3. **Successors and Assigns.** This Assignment of Trademarks shall be binding upon Assignor and shall be to the benefit of Assignee and its successors and assigns.


