THIRD AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

THIS THIRD AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of September 30, 1999, is between AMERISERVE FOOD DISTRIBUTION, INC., a Delaware corporation (the "Company"), and BANK OF AMERICA, NATIONAL ASSOCIATION (successor by merger to Bank of America National Trust and Savings Association), a national banking association, in its capacity as administrative agent under the Credit Agreement referred to below (in such capacity, the "Administrative Agent");

WITNESSETH:

WHEREAS, the Company and the Administrative Agent entered into a Second Amended and Restated Trademark Security Agreement, dated as of May 21, 1998 (as heretofore amended, the "Company's Trademark Agreement"), which was recorded with the United States Patent and Trademark Office on December 3, 1998 at Reel 1822, Frame 0956;

WHEREAS, concurrently with the execution of this Agreement, the Company has entered into a Fourth Amended and Restated Credit Agreement, dated as of September 30, 1999 (as amended, extended, restated, supplemented or otherwise modified or replaced from time to time, the "Credit Agreement"), which amends and restates a Third Amended and Restated Credit Agreement, dated as of May 21, 1998, by and among the Company, the financial institutions from time to time party thereto (collectively the "Lenders"), and the Administrative Agent, pursuant to which the Lenders have agreed to make loans to, and issue or participate in letters of credit for the account of, the Company;

WHEREAS, all obligations of the Company and the Subsidiaries as Guarantors under the Credit Agreement are secured pursuant to a Second Amended and Restated Security Agreement, dated as of May 21, 1998 (as amended or otherwise modified from time to time, the "Security Agreement"; capitalized terms used but not defined herein are used as defined in the Security Agreement);

WHEREAS, ProSource Services Corporation, a subsidiary of ProSource, Inc., merged with and into ProSource, Inc., a Subsidiary of the Company, effective on December 27, 1998, whereupon ProSource, Inc. merged with and into the Company effective on such date;

WHEREAS, ProSource Services Corporation and the Administrative Agent entered into a Trademark Security Agreement, dated as of May 21, 1998 (as heretofore amended, the "ProSource Trademark Agreement"), which was recorded with the United States Patent and Trademark Office on December 2, 1998 at Reel 1821, Frame 0659;

WHEREAS, the parties to the Company's Trademark Agreement wish to amend and restate the Company's Trademark Agreement to confirm the inclusion in the Trademark Collateral covered thereby of (i) the trademark collateral granted pursuant to the ProSource Trademark Agreement and (ii) certain new pending trademark applications of the Company;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Company agrees, for the benefit of the Administrative Agent and the other Secured Parties, that the Company's Trademark Agreement shall be amended and restated in its entirety to read as follows:

SECTION 1 Grant of Security Interest. To secure the payment in full of all Liabilities, the Company hereby mortgages, pledges and hypothecates to the Administrative Agent for the benefit of the Secured Parties, and grants to the Administrative Agent for the benefit of the Secured Parties a security interest in, all of the Company's right, title and interest in and to the following property (the "Trademark Collateral"), whether now owned or hereafter acquired or existing (including rights as licensee or lessee):

- (a) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of a like nature (all of the foregoing items in this clause (a) being collectively called a "Trademark"), now existing anywhere in the world or hereafter adopted or acquired, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any foreign country, including those referred to in Item A of Attachment 1 hereto;
- (b) all Trademark licenses, including each Trademark license referred to in Item B of Attachment 1 hereto;
- (c) all reissues, extensions or renewals of any of the items described in clauses (a) and (b);
- (d) all of the goodwill of the business connected with the use of, and symbolized by the items described in, clauses (a) and (b); and
- (e) all proceeds, products, rents, profits and returns of, and all common law and other rights throughout the world associated with, any of the foregoing, including any claim by the Company against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, including any Trademark, Trademark

registration or Trademark license referred to in <u>Item A</u> and <u>Item B</u> of <u>Attachment 1</u> hereto, or for any injury to the goodwill associated with the use of any Trademark or for breach or enforcement of any Trademark license.

This Agreement is an amendment and restatement of the terms and provisions of the Company's Trademark Agreement. Nothing contained in this Agreement shall be construed to release, cancel, terminate or otherwise affect adversely all or any part of the security interest in the Trademark Collateral granted under the Company's Trademark Agreement, which security interest has been continued and confirmed by the Company hereunder.

SECTION 2 Security Agreement. This Agreement has been executed and delivered by the Company for the purpose of registering the security interest of the Administrative Agent for the benefit of the Secured Parties in the Trademark Collateral with the United States Patent and Trademark Office. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Administrative Agent for the benefit of the Secured Parties under the Security Agreement. The Security Agreement (and all rights and remedies of the Administrative Agent thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 3 Release of Security Interest. Upon payment in full of all Liabilities (other than Liabilities in the nature of continuing indemnification obligations) and the termination of all commitments to create Liabilities, the Administrative Agent shall, at the Company's expense, execute and deliver to the Company all instruments and other documents as may be necessary or proper to release the lien on and security interest in the Trademark Collateral of the Company that have been granted hereunder.

SECTION 4 <u>Acknowledgment</u>. The Company hereby further acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5 <u>Counterparts</u>. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.
