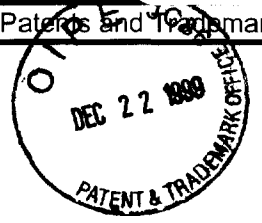

PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that CONGRESS FINANCIAL CORPORATION, a Delaware corporation, successor by merger to Congress Financial, a California corporation ("Secured Party"), having an office at 1133 Avenue of the Americas, New York, New York 10036, DOES HEREBY CERTIFY that the security interest it holds in certain trademarks and trademark applications of AUSTAD HOLDINGS, a Delaware corporation ("Austad Holdings"), pursuant to the Trademark Collateral Assignment and Security Agreement, dated November 14, 1995, by and among HANOVER CATALOG HOLDINGS, INC., a Delaware Corporation, HANOVER DIRECT, INC., a Delaware corporation, SCANDIA DOWN CORPORATION, a Delaware corporation, AEGIS SAFETY HOLDINGS, INC., a Delaware corporation, COMPANY STORE HOLDINGS, INC., a Delaware corporation, and Austad Holdings (each individually, a "Debtor" and collectively, "Debtors") and Secured Party, recorded in the United States Patent and Trademark Office on December 14, 1995, at Reel 1428, Frame 0001, as amended by First Amendment to Trademark Collateral Assignment and Security Agreement, dated February 22, 1996, recorded in the United States Patent and Trademark Office on August 12, 1996, at Reel 1464, Frame 0130, as amended by Second Amendment to Trademark Collateral Assignment and Security Agreement, dated as of September 30, 1998, recorded in the United States Patent and Trademark Office on February 26, 1999, at Reel 1862, Frame 0001 (the "Trademark Security Agreement"), which trademarks and trademark applications are more fully identified on Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, is released and all interest in such property previously assigned to Secured Party under the Trademark Security Agreement is hereby reassigned to Austad Holdings, without representation or warranty of any kind, nature or description.

Nothing contained herein shall constitute a release or reassignment of the security interests or interests in any other trademarks and other property assigned by way of security by Debtors pursuant to the Trademark Security Agreement.
